

**RESOLUTION NO. 17-168**

**RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AMENDING THE POSITION ALLOCATION TABLE PROVIDING FOR THE NUMBER AND COMPENSATION OF OFFICERS, DEPUTIES AND EMPLOYEES IN THE VARIOUS OFFICES OF THE COUNTY OF MENDOCINO**

WHEREAS, the Board of Supervisors has adopted Resolution No. 17-081 which sets forth the classification, salaries, and number of personnel in the various County departments; and

WHEREAS, it is the wish and desire of the Board of Supervisors to amend this resolution to meet the needs of County service; and

WHEREAS, the various affected departments or agencies have agreed to incorporate the positions within their existing fiscal year budgets; and

WHEREAS, the Civil Service Commission, at its September 20, 2017 meeting, approved the new classifications and title changes to existing classifications; and

WHEREAS, the Civil Service Commission at its October 26, 2017 special meeting, supports the title changes and approved the reclassification of one incumbent; and

WHEREAS, Attachment A represents the Position Allocation Table changes requested for Budget Unit 5010; and

WHEREAS, the County has fulfilled its obligation with the affected bargaining units.




