

BOS AGREEMENT NO. BOS 15-089

AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. <u>BOS 15-089</u>

WHEREAS, BOS Agreement No. <u>BOS 15-089</u> was entered into on <u>September 8, 2015</u>; and

WHEREAS, BOS Agreement No. <u>BOS 15-089</u> was amended on <u>June 9, 2016</u> to extend the expiration date from June 30, 2016 to June 30, 2017; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and <u>CONTRACTOR</u>, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the amended BOS Agreement No. <u>BOS 15-089</u>, from <u>June 30, 2017</u> to <u>June 30, 2018</u>; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total contract amount set out in BOS Agreement No. <u>BOS 15-089</u>, from <u>Ninety Five Thousand Dollars</u> (\$95,000.00) to <u>Two Hundred Eighty Five Thousand Dollars</u> (\$285,000.00); and

WHEREAS, BOS Agreement No. 15-089 allowed three (3) one-time one-year extensions.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the amended BOS Agreement No. <u>BOS 15-089</u> will be extended from <u>June 30, 2017</u> to <u>June 30, 2018</u>.
- 2. The total contract amount set out in BOS Agreement No. <u>BOS 15-089</u> will be increased from <u>Ninety Five Thousand Dollars (\$95,000.00)</u> to <u>Two Hundred Eighty Five Thousand Dollars (\$285,000.00)</u>

All other terms and conditions of BOS Agreement No. <u>BOS 15-089</u> shall remain in full force and effect.
