NOW THEREFORE BE IT RESOLVED that the Mendocino County Board of Supervisors does hereby ratify the Ordinance of the District adopting the 2010 Edition of the California Fire Code With Amendments, Regulating and Governing the Safeguarding of Life and Property From Fire and Explosion And For Providing For the Issuance Of Permits, Repealing All Other Ordinances and parts of Ordinances of the Ukiah Valley Fire District In Conflict Herewith:
