

RESOLUTION NO. 17-195

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS REAFFIRMING THE EXISTENCE OF LOCAL HEALTH EMERGENCY AS PROCLAIMED BY THE HEALTH OFFICER

WHEREAS, the California Health and Safety Code, Division 101, Part 3, Chapter 2, commencing with §101075 confers upon Local Health Officers of the political subdivisions of this state emergency powers necessary to protect public health and safety;

WHEREAS, §101080 of the California Health and Safety Code, states that "the local health officer may declare a local health emergency in the jurisdiction or any area thereof" affected by hazardous waste which is an imminent threat to the public health;

WHEREAS, Health and Safety Code Section 101080 empowers the local health officer to proclaim the existence of a local health emergency when this county or any area of the county is affected or likely to be affected by such a public health threat while the Board of Supervisors is not in session, which shall expire if not ratified by the Board of Supervisors within seven days and is subject to review every 14 days thereafter until such local health emergency is terminated;

WHEREAS, on October 13, 2017, the local health officer of the County of Mendocino issued a declaration of local health emergency due to the hazardous debris generated by the Redwood Complex Fire;

WHEREAS, on October 17, 2017, the Board of Supervisors of the County of Mendocino ratified the declaration of local health emergency by the local health officer due to the hazardous debris generated by the Redwood Complex Fire; and

WHEREAS, on October 31, 2017, November 14, 2017, November 21, 2017, and December 5, 2017, the Board of Supervisors of the County of Mendocino adopted Resolution Nos. 17-154, 17-167, 17-173 and 17-179 respectively, reaffirming the existence of a local health emergency due to the hazardous debris generated by the Redwood Complex Fire.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of Mendocino hereby finds that a local health emergency continues to exist and therefore reaffirms the proclamation of local health emergency.

The foregoing Resolution introduced by Supervisor Gjerde, seconded by Supervisor Croskey, and carried this 19th day of December, 2017, by the following vote:
