RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS TO AUTHORIZE MENDOCINO COUNTY HEALTH AND HUMAN SERVICES AGENCY (HHS), BEHAVIORAL HEALTH AND RECOVERY SERVICES (BHRS) DIRECTOR OR DESIGNEE TO SIGN THE STATE OF CALIFORNIA, DEPARTMENT OF HEALTH CARE SERVICES AGREEMENT NUMBER 17-94140 (SUBSTANCE USE DISORDER SERVICES GRANT) AND ALLOW THE BHRS DIRECTOR OR DESIGNEE TO SIGN ANY FUTURE AMENDMENTS OR RENEWALS THAT DO NOT EXCEED THE MAXIMUM AMOUNT ASSOCIATED WITH THE GRANT

WHEREAS, the Board of Supervisors of the County of Mendocino (Board) has read the proposed Agreement between the State of California, Department of Health Care Services and the Mendocino County Health and Human Services Agency; and

WHEREAS, the Board acknowledges the benefits and responsibilities to be shared by both parties to said agreement; and

WHEREAS, this Agreement is to prevent and treat substance abuse through utilization of Substance Abuse Block Grant (SABG) funds pursuant to Section 1921 of Title XIX, Part B, Subpart II and III of the Public Health Service Act, for services rendered by county-operated or county-contracted substance use disorder service providers; and

WHEREAS, State and the County of Mendocino enter into this contract by authority of Title 45 of the Code of Federal Regulations Part 96 (45 CFR Part 96), Substance Abuse Prevention and Treatment Block Grants (SABG) for the purpose of planning, carrying out and evaluating activities to prevent and treat substance abuse.

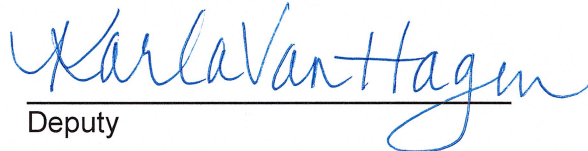
NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors approves the Substance Use Disorder Services grant, directs the Auditor Controller to create fiscal information and does hereby authorize Director or designee of the Mendocino County Health and Human Services Agency, Behavioral Health and Recovery Services to sign and execute said agreement and any amendments or renewals thereto that do not increase the maximum total.

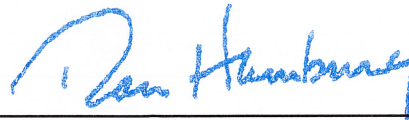

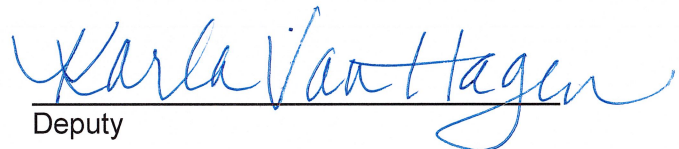
