

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 17-043**

This Amendment to BOS Agreement No. 17-043 is entered into this 27th day of February, 2018, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Liebert Cassidy Whitmore, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 17-043 was entered into on July 1, 2017; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Liebert Cassidy Whitmore, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to decrease the amount of BOS Agreement No. 17-043 by \$75,000 for a revised total agreement amount of \$175,000.

NOW, THEREFORE, we agree as follows:

1. To decrease BOS Agreement No. 17-043 by \$75,000 for a revised total agreement amount of \$175,000.

All other terms and conditions of BOS Agreement No. 17-043 shall remain in full force and effect.
