AMENDMENT TO PURCHASING AGENT AGREEMENT NO. 18-69

WHEREAS, PA Agreement No. 18-69 was entered into on October 15, 2017; and

WHEREAS, PA Agreement No. <u>18-69</u> was amended by PA Agreement No. <u>18-69A1</u>, <u>effective November 7, 2017</u>; and

WHEREAS, PA Agreement No. <u>18-69</u> was amended a second time by BOS Agreement No. <u>18-002</u>, effective January 9, <u>2018</u>; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Robert Ochs, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of the COUNTY to increase PA Agreement No. <u>18-69 as</u> amended by PA Agreement No. <u>18-69A1</u>, and BOS Agreement No. <u>18-002</u>, in the amount of \$15,000 for an Agreement total of \$95,000; and

WHEREAS, it is the desire of the COUNTY to change PA Agreement No. <u>18-69 as</u> amended by PA Agreement No. <u>18-69A1</u>, and BOS Agreement No. <u>18-002</u>, contract termination date from <u>March 31</u>, <u>2018</u>, to <u>February 24</u>, <u>2018</u>.

NOW, THEREFORE, the parties agree as follows:

- 1. To increase PA Agreement No. <u>18-69 as amended by PA Agreement No. <u>18-69A1</u>, and BOS Agreement No. <u>18-002</u>, in the amount of \$15,000 for a total Agreement amount not to exceed \$95,000.</u>
- 2. To change PA Agreement No. <u>18-69 as amended by PA Agreement No. <u>18-69A1</u>, and BOS Agreement No. <u>18-002</u>, to a contract end date of February 24, 2018.</u>

All other terms and conditions of PA Agreement No. <u>18-69 as amended by PA Agreement No. 18-69A1</u> and BOS Agreement No. <u>18-002</u>, shall remain in full force and effect.
