## AMENDMENT TO COUNTY OF MENDOCINO STANDARD SERVICES AGREEMENT NO. JA-J17-002 & PA 18-77

WHEREAS, it is the desire of the CONTRACTOR and the COUNTY to increase the total amount of Agreement #JA-J17-002 & PA 18-77 by adding \$10,000 changing the total amount of the agreement from \$50,000 to \$60,000;

NOW, THEREFORE, we agree as follows:

- 1. **Amount of agreement:** The amount set out in the original Agreement No. JA-J17-002 & PA 18-77 will be changed from \$50,000 to \$60,000.
- 2. **Payment Terms:** The Payment Terms, Exhibit B, set out in the original Agreement No. JA-J17-002 & PA 18-77 will change from \$50,000 to \$60,000.

All other terms and conditions of Agreement No. <u>JA-J17-002 & PA 18-77</u> shall remain in full force and effect.
