- 1. **Amount of agreement:** The amount set out in the original Agreement No. JA-J17-017, PA 18-34 will be changed from \$50,000 to \$400,000.
- 2. **Payment Terms:** The Payment Terms, Exhibit B, set out in the original Agreement No. JA-J17-017, PA 18-34 will change from \$50,000 to \$400,000.

All other terms and conditions of Agreement No. <u>JA-J17-017</u>, PA 18-34 shall remain in full force and effect.
