

**AMENDMENT TO COUNTY OF MENDOCINO
STANDARD SERVICES AGREEMENT NO. JA-J17-017, PA 18-34**

This Amendment to Agreement No. JA-J17-017, PA 18-34 is entered into this 27th day of February, 2018, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Trinity Services Group, Inc., hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. JA-J17-017, PA 18-24 was entered into on August 18, 2017; and

WHEREAS, upon execution of this document by the County of Mendocino and the Contractor, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of the CONTRACTOR and the COUNTY to increase the total amount of Agreement #JA-J17-017, PA 18-34 by adding \$350,000 changing the total amount of the agreement from \$50,000 to \$400,000.

NOW, THEREFORE, we agree as follows:

1. **Amount of agreement:** The amount set out in the original Agreement No. JA-J17-017, PA 18-34 will be changed from \$50,000 to \$400,000.
2. **Payment Terms:** The Payment Terms, Exhibit B, set out in the original Agreement No. JA-J17-017, PA 18-34 will change from \$50,000 to \$400,000.

All other terms and conditions of Agreement No. JA-J17-017, PA 18-34 shall remain in full force and effect.
