It has come to the attention of the Roofers & Waterproofers Union Local #81 that CVE NB Contracting Group, Inc. / Central Valley Environmental CSLB #974852 is listed for roof related work on the project listed above.

Please consider this a letter of protest regarding Central Valley Environmental for the following reasons:

- No C-39 License that is required by the State of CA to perform roof removal work (License Detail enclosed)
- No Workers' Compensation for Roofing required for roof removal work (Workers' Compensation Coverage enclosed)
- Will not be able to employ registered apprentices required by the State of CA for roof related work without the proper license classification and workers' compensation.

Therefore, Central Valley Roofing should not have been able to bid, or be listed, to perform any roof removal or any roof related work on any project.
