

**RESOLUTION NO. 17-161****RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS DECLARING ITS INTENTION TO CONSIDER ROAD NAME CHANGE PETITION NUMBER 17-01 AND SUMMARY ROAD VACATION PETITION NUMBER 17-01 PROCEEDINGS OF COUNTY ROAD 141, COX SCHRADER ROAD (FRONTAGE ROAD E), (UKIAH AREA)**

WHEREAS, pursuant to the provisions of the California Streets and Highways Code, for road name changes and summary road vacations of County Highways; and

WHEREAS, by petitions Road Name Change Petition Number (No.) 17-01 and Summary Road Vacation No. 17-01; property owners of the land adjacent to and surrounding County Road (CR) 141, Cox Schrader Road (Frontage Road E) and the appropriate amount of freeholders, have requested the road name change and subsequent summary road vacation of that road described as follows:

That County Road known as CR 141, Cox Schrader Road (Frontage Road E) that is accessed and adjacent to the State Highway 101 Cox Schrader Exit No. 545; and

WHEREAS, the prescribed fees have been paid and Road Name Change Petition No. 17-01 and Summary Road Vacation Petition No. 17-01 have been found to be in sufficient order to proceed with the road name change and summary road vacation processes; and

WHEREAS, in an effort to change the name of State Highway 101 Exit No. 545, Cox Schrader, the petitioners have submitted Road Name Change Petition No. 17-01 to change CR 141, Cox Schrader Road (Frontage Road E) to Rivino Ranch Road per California Department of Transportation (Caltrans) instruction; and

WHEREAS, the petitioners have also submitted Summary Road Vacation Petition No. 17-01 to summarily vacate CR 141, Cox Schrader Road (Frontage Road E) for security reasons; and

WHEREAS, Summary Road Vacation Petition No. 17-01 meets the requirement to be considered as a summary road vacation pursuant to California Streets and Highways Code Section 8334 which provides "a portion of a street that lies within property under one ownership and that does not continue through such ownership or end touching property of another."




