#### PROPOSED NAME CHANGE AND ROAD VACATION COUNTY ROAD 141, COX SCHRADER ROAD (FRONTAGE ROAD E), OUTLINE FOR BOARD OF SUPERVISORS PROCEEDINGS AND PUBLIC HEARING

#### APRIL 24, 2018

Before Chair proceeds and addresses "Proper Notice," it is appropriate to have Director of Transportation give introduction of topic, during which he will show that proper notice has been given.

### I. DETERMINE THAT PROPER NOTICE HAS BEEN GIVEN UNDER STREETS AND HIGHWAYS (S&H) CODE

- A. Notice published in *The Ukiah Daily Journal* April 6, April 13, and April 20, 2018.
- B. Notice posted in 14 locations on Cox Schrader Road and elsewhere on March 20, 2018.
- C. Notice mailed to petitioner and all qualified signatories of petition on March 20, 2018.

A. Caltrans recommends that the petitioner (aka property owner) obtain an encroachment permit, which includes the evidence of easements, for each of the parcels subject to the highway access to identify the current owner's responsibility for maintenance of what will become a private road approach.

## IV. RECEIVE REPORT FROM TRANSPORTATION (Report in form of letter to Board of Supervisors, dated April 24, 2018).

- A County Road (CR) 141, Cox Schrader Road (Frontage Road E) is part of the County Maintained Road System.
- B. Mendocino County Department of Transportation (DOT) acquired this road from Caltrans through a relinquishment recorded in Book 717, Official Records, Page 385 and is depicted on the Caltrans Right of Way Map Number (No.) 67 of 1-MEN-1-B.
- C. This road is not located near a public recreational area or within close proximity to a waterway therefore it does not provide potential public access to such.
- D. There are no public utilities located in the proposed area to be vacated so there is no impact to potential utilities.
- E. The proposed road vacation is held in fee interest therefore it is DOT's recommendation that we reserve all previous ownerships of right of way that currently exist for furnishing ingress and egress to and from the existing properties over the County Road to be vacated to the freeway access encroachment area. (Per Streets and Highway Code section 8352).

#### IX. IF RESOLUTIONS OF NAME CHANGE AND VACATION ARE TO BE ADOPTED
