## RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS CHANGING THE NAME OF COUNTY ROAD 141, COX SCHRADER ROAD (FRONTAGE ROAD E), TO RIVINO RANCH ROAD (UKIAH AREA)

WHEREAS, the County Department of Transportation duly received Road Name Change Petition Number (No.) 17-01 requesting the change of official name for County Road (CR) 141, Cox Schrader Road (Frontage Road E), milepost (M.P.) 0.0 to M.P. 0.10, to Rivino Ranch Road; and

WHEREAS, during the November 7, 2017, Board of Supervisors meeting, the Department of Transportation presented the above-named petition to the Board for consideration of setting a public hearing; and

WHEREAS, by Resolution No. 17-161, the Board of Supervisors approved setting a public hearing on April 24, 2018, to receive staff reports and comments and testimony from the public concerning the proposed road name change; and

WHEREAS, notice of the public hearing was duly made pursuant to Streets and Highways Code section 970.5; and

WHEREAS, during its meeting of April 24, 2018, the Mendocino County Board of Supervisors did conduct a public hearing to receive staff reports and entertain and consider comments by the general public concerning Road Name Change Petition No. 17-01; and

WHEREAS, the Board of Supervisors of Mendocino County has determined that the requested road name change set forth in Petition No. 17-01 is appropriate.

NOW THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors does hereby approve the requested road name change as shown and set forth in Petition No. 17-01, which petition is attached to this Resolution as Exhibit A and incorporated by this reference, namely:

Petition No. 17-01 (Affecting CR 141, Cox Schrader Road (Frontage Road E).

Change the name of CR 141 Cox Schrader Road (Frontage Road E) to the official name of CR 141 Rivino Ranch Road. The change is for the entire length of CR 141.

BE IT FURTHER RESOLVED that the Department of Transportation is hereby authorized and directed to adjust the County's Maintained Mileage listing as follows:

(Remove) CR 141, Cox Schrader Road (Frontage Road E) -- length = .10 miles (Add) CR 141, Rivino Ranch Road -- length = .10 miles
