WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original PA Agreement No. 18-74, from May 31, 2018 to June 30, 2018; and

WHEREAS, it is the desire of the CONTRACTOR and COUNTY to increase the total contract set out in the original PA Agreement No. 18-74, from Fifty Thousand Dollars (\$50,000) to Seventy-Five Thousand Dollars (\$75,000).

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the original PA Agreement No. 18-74 will be extended from May 31, 2018 to June 30, 2018.
- 2. The total contract amount set out in PA Agreement No. 18-74 will be increased from Fifty Thousand Dollars (\$50,000) to Seventy-Five Thousand Dollars (\$75,000).

All other terms and conditions of PA Agreement No. 18-74 shall remain in full force and effect.
