## **AMENDMENT NO. 2**

## TO AGREEMENT FOR PROFESSIONAL SERVICES

This Amendment No. 2, dated February 13, 2018, is entered into, by and between the County of Sonoma, a political subdivision of the State of California (hereinafter "County"), and County of Mendocino (hereinafter "Second County").

WHEREAS, on October 1, 2016, County and Second County entered into an Agreement for Second County to place out-of-county youth in Sonoma County Juvenile Hall and/or Probation Camp, and

WHEREAS, Section 3 of the Agreement includes the option to extend the term of the agreement up to two (2) times for a period of one (1) year per extension, with the same terms and conditions as set forth in the Agreement, and

WHEREAS, the parties executed Amendment 1 to exercise the first option year to extend the contract period from October 1, 2016 through June 30, 2018, and

WHEREAS, the parties wish to amend the Agreement for the purposes of increasing the payment amount and exercising the second option year to extend the Agreement,

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties hereto agree as follows:

Section 2.1.3. Payments made to County under this Agreement shall not exceed \$105,000.

Section 3. The term of agreement shall be from October 1, 2016 through June 30, 2019.

All other provisions of the Agreement are unchanged and shall remain in full force and effect throughout the remaining balance of the term of the Agreement.
