**RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS SETTING
COMPENSATION FOR ASSISTANT COUNTY COUNSEL, CHIEF DEPUTY COUNTY
COUNSEL, AND DEPUTY COUNTY COUNSEL I-IV**

WHEREAS, the Board of Supervisors has adopted Resolution No.17-081 which sets forth the classification, salaries, and number of personnel in the various County departments; and

WHEREAS, it is the intent of the Board of Supervisors to review the salaries and terms and conditions of employment and determine what adjustments, if any, shall be made, and

WHEREAS, the various affected departments or agencies have agreed to incorporate the positions within their existing fiscal year budgets; and

WHEREAS, it is the desire of the Board of Supervisors to maintain the County Counsel (attorney) classifications at five percent (5%) differential above the attorney classifications represented by the Mendocino County Public Attorney Association (MCPAA), now and in the future, based on salary negotiations of MCPAA; and

WHEREAS, with the exception of salary, it is the desire that the unrepresented County Counsel classifications continue to receive the benefits of the Department Head Association Memorandum of Understanding, in accordance with Resolution No. 10-006 and as amended by subsequent resolutions.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby authorizes salary changes and the Position Allocation Table of said Resolution to be amended as follows:

Budget Unit 1210 – County Counsel

Classification Salary

Assistant County Counsel	\$97,697.60 - \$119,267.20
Chief Deputy County Counsel	\$93,038.40 - \$113,588.80
Deputy County Counsel IV	\$88,608.00 - \$108,180.80
Deputy County Counsel III	\$75,150.40 - \$91,748.80
Deputy County Counsel II	\$64,376.00 - \$78,603.20
Deputy County Counsel I	\$57,096.00 - \$69,388.80

BE IT FUTHER RESOLVED that the Mendocino County Board of Supervisors hereby authorizes future salary increases for the above classifications to maintain five percent (5%) between the County Counsel attorney classifications and attorney classifications represented by MCPAA.

The effective date of this Resolution shall be April 8, 2018 to coincide with the beginning of Pay Period 9-18.
