Re: Application for Business License for Cannabis Dispensary at 45110 Main Street

It is our understanding that Board of Supervisors is considering revised language that would allow businesses to apply for a setback reduction and other exceptions as applicable to this Business License application. We are opposed to this reduction and exceptions.

#### Concerns include but are not limited to:

- \* First and foremost, this is not an appropriate business for a tourist location like Main Street, Mendocino. A business like this serves its own local clientele and not tourists who would purchase their own cannabis from their own dispensary. Additionally, the appearance of the dispensary is not conducive to a tourist area with the requirement that the windows being curtained rather than a pleasing window display.
- \* Safety which is a prime concern to the nearby businesses and residents all of whom only have access to their homes from street parking. There is no security to ensure that the businesses and residents are not impacted by loitering and other criminal activity during the day and especially after dark.
- \* Parking problems (expressed by many nearby businesses) and there is no off-street parking and on weekends parking is already difficult. Additionally, as it has been stated this is primarily for medical use and there are no accessible spaces nor is the buildings entrance ADA compliant.
- \* Where the cliental is going to go to consume the product after purchasing. For example, if someone purchases a glass of wine at a local restaurant they sit inside and drink it. If someone purchases cannabis from the dispensary do they sit on the front porch or go over to the picnic benches at the State Park to consume it? From where and when is the product delivered as Albion Street is residential.
- \* Structural and non-structural changes (demolishing or improvements) that alter the building in use, design or arrangement such as the removal of the skylights and altering the entrance to the building.
- \* Finally, the distance to schools, parks and churches is **all less than 1000 feet**. The Headlands State Park is often if not daily occupied by children flying kites or playing ball or frisbee. It is also a frequent destination for school field trips and school picnics.

It appears from the application that there are potentially five reasons to deny the license:

- \* Lack of off street and accessible parking
- \* Adjacency to Mendocino High School (from property line to property line)
- \* Adjacency to the Baptist Church
- \* Adjacency to Temple of Kwan Tai
- \* Adjacency to Mendocino Headlands State Park (frequented by children daily both with parents and school groups)

The property has been an art gallery for at least 50 years and it is surrounded by both vacation residences and full-time residences. There is no precedence that this use is grandfathered in. Attached are critical County documents highlighted for emphasis.
