

**AMENDMENT TO BOARD OF SUPERVISORS  
AGREEMENT NO. 16-053**

This Amendment to BOS Agreement No. 16-053 is entered into this 22 day of May, 2018, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Governmentjobs.com dba "NEOGOV", hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 16-053 was entered into on July 12, 2016; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and NEOGOV, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. 16-053, from June 30, 2018 to June 30, 2019; and

WHEREAS, the renewal cost is effective July 1, 2018 and is attached as Exhibit A, and;

WHEREAS, it is the desire of the COUNTY to increase the total contract in the amount of \$52,288 for a new contract total of \$157,450,

NOW, THEREFORE, the parties agree as follows:

1. The termination date set out in the original BOS Agreement No. 16-053 will be extended from June 30, 2018 to June 30, 2019.
2. The renewal cost is effective July 1, 2018 and is attached as Exhibit A.
3. To increase the total contract in the amount of \$52,288 for a new contract total of \$157,450.

All other terms and conditions of BOS Agreement No. 16-053 shall remain in full force and effect.
