

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 17-063**

This Amendment to BOS Agreement No. 17-063 is entered into this 22 day of May, 2018, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Canyon Manor, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 17-063 was entered into on July 18, 2017; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Canyon Manor, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, CONTRACTOR will provide a residential care facility offering a broad range of services to residents who require a structured environment due to mental health challenges.


NOW, THEREFORE, we agree as follows:

1. **Amount of Agreement:** The amount set out in the original BOS Agreement No. 17-063 will be changed from \$222,753 to \$455,520.




