**AN ORDINANCE OF THE
MENDOCINO COUNTY BOARD OF
SUPERVISORS AMENDING CHAP-
TER 6.36 -CANNABIS FACILITIES
BUSINESSES AND CHAPTER
20.243 - CANNABIS FACILITIES**

This ordinance is making several updates, revisions and additions to various sections of Chapters 6.36 and 20.243 of the Mendocino County Code regarding the County's cannabis facilities business licenses and zoning requirements for cannabis facilities. Proposed amendments include modifying the chapters to apply to both medical and adult use cannabis facilities, changes to better align the terms and definitions of the ordinance with those of State law and regulations, and changes regarding administrative permit and zoning requirements.

Passed and adopted by the Board of Supervisors of the County of Mendocino, State of California, on this 5th day of June, 2018, by the following vote:
