## AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. PA 17-23, BOS 17-142

This Amendment to Agreement No. PA 17-23 & BOS 17-142 is entered into this QTH day of June, 2018, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Mendocino County Youth Project (MCYP), hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. PA 17-23 was entered into on August 17, 2016; and

WHEREAS, Agreement No. <u>PA 17-23</u> was amended on <u>November 15, 2017</u> to extend the termination date to June 30, 2018 and increase the total contract amount from \$38,209.00 to \$76,418.00 (BOS 17-142);

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and <u>CONTRACTOR</u>, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in Agreement No. <u>PA 17-23, BOS 17-142</u>, from <u>June 30, 2018</u> to <u>June 30, 2019</u>; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase total contract amount set out in Agreement No. <u>PA 17-23, BOS 17-142</u>, from <u>Thirty Eight Thousand Two Hundred Nine Dollars (\$38,209.00)</u> to <u>One Hundred Fourteen Thousand Six Hundred Twenty Seven Dollars (\$114,627.00)</u>; and

WHEREAS, Agreement No. <u>PA 17-23</u> allowed three (3) one-time one-year extensions. With the approval of this amendment there will be one (1) further extension available.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in BOS Agreement No. <u>17-142</u> will be extended from <u>June 30, 2018</u> to <u>June 30, 2019</u>.
- 2. The total contract amount set out in BOS Agreement No. <u>17-142</u> will be increased from <u>Thirty Eight Thousand Two Hundred Nine Dollars</u> (\$38,209.00) to <u>One Hundred Fourteen Thousand Six Hundred Twenty Seven Dollars</u> (\$114,627.00).

All other terms and conditions of Agreement No. PA 17-23, BOS 17-142 shall remain in

full force and effect.
