AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. 16-078, 16-078-A1

This Amendment to BOS Agreement No. 16-078, 16-078-A1 is entered into this day of June, 2018, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Mendocino County Youth Project (MCYP), hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 16-078 was entered into on September 13, 2016; and

WHEREAS, BOS Agreement No. <u>16-078</u> was amended on <u>November 15, 2017</u> to extend the termination date from June 30, 2017 to June 30, 2018; reduce contracted hours from 30 hours per week to 20 hours per week; and increase the total contract amount set out in BOS 16-078 from \$78,698.00 to \$140,673.00; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and <u>CONTRACTOR</u>, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in BOS Agreement No. <u>16-078, 16-078-A1</u>, from <u>June 30, 2018</u> to <u>June 30, 2019</u>; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase total contract amount set out in BOS Agreement No. 16-078, 16-078-A1, from One Hundred Forty Thousand Six Hundred Seventy Three Dollars (\$140,673.00) to Two Hundred Five Thousand Seven Hundred Forty Seven Dollars (\$205,747.00); and

WHEREAS, BOS Agreement No. <u>16-078</u> allowed three (3) one time one year extensions. With the approval of this amendment there will be one (1) further extension available.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in BOS Agreement No. <u>16-078-A1</u> will be extended from <u>June 30, 2018</u> to <u>June 30, 2019</u>.
- 2. The total contract amount set out in BOS Agreement No. <u>16-078</u> will be increased from <u>One Hundred Forty Thousand Six Hundred Seventy Three Dollars (\$140,673.00)</u> to <u>Two Hundred Five Thousand Seven Hundred Forty Seven Dollars (\$205,747.00)</u>.

All other terms and conditions of BOS Agreement No. <u>16-078, 16-078-A1</u> shall remain in full force and effect.
