AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. 17-075

This Amendment to BOS Agreement No. 17-075 is entered into this 1st day of July, 2018, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and FORD STREET PROJECT, hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. PR-P16-001 was entered into on July 2, 2015; and

WHEREAS, Agreement No. PR-P16-001 was entered into on May 25, 2016; and

WHEREAS, BOS Agreement No 17-075 was entered into on August 1, 2017; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and <u>Contractor</u>, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in BOS Agreement No. <u>17-075</u>, from <u>June 30</u>, <u>2018</u> to <u>June 30</u>, <u>2019</u>; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total contract amount set out in BOS Agreement No. <u>17-075</u> from <u>Sixty Thousand Dollars (\$60,000)</u> to <u>Eighty Thousand Dollars (\$80,000)</u>.

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in BOS Agreement No. <u>17-075</u> will be extended from June 30, 2018 to June 30, 2019.
- 2. The total contact amount set out in BOS Agreement No. <u>17-075</u> will be increased from <u>Sixty Thousand Dollars (\$60,000)</u> to <u>Eighty Thousand Dollars (\$80,000)</u>.

All other terms and conditions of BOS Agreement No. <u>17-075</u> shall remain in full force and effect.
