

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 17-075**

This Amendment to BOS Agreement No. 17-075 is entered into this 1st day of July, 2018, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and FORD STREET PROJECT, hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. PR-P16-001 was entered into on July 2, 2015; and

WHEREAS, Agreement No. PR-P16-001 was entered into on May 25, 2016; and

WHEREAS, BOS Agreement No 17-075 was entered into on August 1, 2017; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Contractor, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in BOS Agreement No. 17-075, from June 30, 2018 to June 30, 2019; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total contract amount set out in BOS Agreement No. 17-075 from Sixty Thousand Dollars (\$60,000) to Eighty Thousand Dollars (\$80,000).

NOW, THEREFORE, we agree as follows:

1. The termination date set out in BOS Agreement No. 17-075 will be extended from June 30, 2018 to June 30, 2019.
2. The total contact amount set out in BOS Agreement No. 17-075 will be increased from Sixty Thousand Dollars (\$60,000) to Eighty Thousand Dollars (\$80,000).

All other terms and conditions of BOS Agreement No. 17-075 shall remain in full force and effect.
