## AMENDMENT TO BOARD OF SUPERVISORS AGREEMENT NO. 16-044, 16-044-A1

This Amendment to BOS Agreement No.<u>16-044, 16-044-A1</u> is entered into this 19th day of March, 2018, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and <u>B.I. Incorporated d/b/a/ BI Correctional Services Inc.</u>, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 16-044 was entered into on June 21, 2016; and

WHEREAS, BOS Agreement No.16-044 was amended on June 30, 2017 to extend the expiration date from June 30, 2017 to June 30, 2018 and increases the total contract amount from Three Hundred and Sixty Thousand Dollars (\$360,000.00) to Seven Hundred and Twenty Thousand Dollars (\$720,000.00);

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in BOS Agreement No. <u>16-044-A1</u>, from <u>June 30, 2018</u> to <u>June 30, 2019</u>; and

WHEREAS, it is the desire of the CONTRACTOR and COUNTY to increase the total contract amount set out in BOS Agreement No. <u>16-044-A1</u> from <u>Seven Hundred and Twenty Thousand Dollars</u> (\$720,000.00) to One Million and Eighty Thousand Dollars (\$1,080,000.00).

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in BOS Agreement No. <u>16-044-A1</u> will be extended from <u>June 30, 2018</u> to <u>June 30, 2019</u>.
- 2. The total contact amount set out in BOS Agreement No. <u>16-044-A1</u> will be increased from <u>Seven Hundred and Twenty Thousand Dollars (\$720,000.00)</u> to One Million and Eighty Thousand Dollars (\$1,080,000.00).

All other terms and conditions of BOS Agreement No. <u>16-044, 16-044-A1</u> shall remain in full force and effect.
