

AMENDMENT TO COUNTY OF MENDOCINO STANDARD SERVICES AGREEMENT NO.

This Amendment to Agreement and Amendment #'s <u>JA-J17-017</u>, <u>PA 18-34</u>, <u>BOS 18-020</u> is entered into this <u>day of <u>JM-</u>2018, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and <u>Trinity Services Group</u>, <u>Inc.</u>, hereinafter referred to as "CONTRACTOR".</u>

WHEREAS, Agreement and Amendment #'s <u>JA-J17-017</u>, <u>PA 18-34</u>, <u>BOS 18-020</u> were entered into on <u>August 18</u>, <u>2017</u> and <u>February 27</u>, <u>2018</u>; and

WHEREAS, upon execution of this document by the County of Mendocino and the Contractor, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of the CONTRACTOR and the COUNTY to extend the term of Agreement and Amendment #'s <u>JA-J17-017</u>, <u>PA 18-34</u>, <u>BOS 18-020</u> from June 30, 2018 to December 31, 2018; and

WHEREAS, it is the desire of the CONTRACTOR and the COUNTY to increase the total amount of Agreement and Amendment #'s <u>JA-J17-017</u>, <u>PA 18-34</u>, <u>BOS 18-020</u> by adding \$50,000 changing the total amount of the agreement from \$400,000 to \$450,000.

NOW, THEREFORE, we agree as follows:

- 1. **Term of Agreement:** The term set out in the original Agreement and Amendment #'s <u>JA-J17-017</u>, <u>PA 18-34</u>, <u>BOS 18-020</u> will be changed from June 30, 2018 to December 31, 2018.
- 2. **Amount of Agreement:** The amount set out in the original Agreement and Amendment #'s <u>JA-J17-017</u>, <u>PA 18-34</u>, <u>BOS 18-020</u> will be changed from <u>\$400,000</u> to <u>\$450,000</u> with the addition of \$50,000.

All other terms and conditions of Agreement and Amendment #'s <u>JA-J17-017</u>, <u>PA 18-34</u>, <u>BOS 18-020</u> shall remain in full force and effect.
