Honorable Board Members:

The Department of Transportation (DOT) has finalized plans and specifications for DOT Project Number (No.) F-1706.101PR to construct permanent repairs to the 2017 Storm Damage Site located on Mountain View Road, County Road (CR) 510, Milepost (MP) 22.02, in the unincorporated area west of the town of Boonville.

For this project, the County must acquire additional rights of way from Justin Jacobson Delmer. DOT has obtained an Acquisition of Right of Way Agreement and Grant Deed executed by the property owner for the rights of way required. We now request the Board approve said Acquisition of Right of Way Agreement, DOT Agreement No. 180067, and accept the Grant Deed for the conveyance of real property to the County.

It is also recommended that the Board authorize and direct the Chair of the Board to execute the Statutory Certificate of Acceptance and direct the Clerk of the Board to submit the Grant Deed to the County Department of Transportation office for further processing and recording.


