We acquired our Homes legally under the laws of the State Of California. We legally formed our Homeowner's Association for the purpose of protecting our homes in the 1970's. We are the only YOKAYO TRIBE OF INDIANS HOMEOWNER'S ASSOCIATION. We are the only Legal members of the Yokayo Tribe of Homeowner's Association, with the legal right to claim and conduct business using "THE YOKAYO TRIBE OF INDIANS HOMEOWNER'S ASSOCIATION" name.

Please be advised there is a new group of people who are fraudulently misrepresenting themselves as being Our Legal Homeowner's Association! Most are not even members of The Yokayo Tribe Of Indians, and Their Descendants By Blood, To The Exclusion of All Other Indians. Therefore they can not legally be a "YOKAYO TRIBE OF INDIAN HOME OWNER"! These people took it upon themselves to reorganize our Association while we are in mourning of our Beloved Sister and Aunt PAULINE MITCHELL ELLIOTT DOWNS. These people use Harassment, threats, intimidation, and fraud to achieve their goals! Our most respected Elder Tribe Member, MARY MITCHELL WHITEROCK, is continually being harassed by these people. As well as her disabled daughters who try to protect her, and her women's Club's clubhouse. Lead by Tyron Mitchell and his family without legal authorization and authority to do so.

This organization is not legal! This organization and the members thereof do not represent "THE YOKAYO TRIBE OF INDIANS AND THEIR DESCENDANTS BY BLOOD TO THE EXCLUSION OF ALL OTHER INDIANS". Not our members, not our interests, and not our tribal land!
