This Amendment to Agreement No. PH-17-038, PA 18-90 is entered into this 24TH day of July, 2018, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Patricia Humphrey Warner, DVM, hereinafter referred to as "CONTRACTOR".

WHEREAS, Agreement No. PH-17-038, PA 18-90 was entered into on December 7, 2017; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Patricia Humphrey Warner, DVM, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the original Agreement No. PH-17-038, PA 18-90, from \$50,000 to \$95,000; and

WHEREAS, CONTRACTOR will provide spay and neuter surgeries and veterinary care for shelter animals.

NOW, THEREFORE, we agree as follows:

1. **Agreement Amount:** The amount set out in the original Agreement No. PH-17-038, PA 18-90 will increase from \$50,000 to \$95,000.

All other terms and conditions of Agreement No. PH-17-038, PA 18-90 shall remain in full force and effect.
