ROAD 510, MILEPOST 14.50, PROJECT NO. F-1706.202PR (BOONVILLE AREA)

Honorable Board Members:

The Department of Transportation (DOT) has finalized plans and specifications for DOT Project Number (No.) F-1706.202PR to construct permanent repairs to the 2017 January Storm Damage site located on Mountain View Road, County Road (CR) 510, Milepost (MP) 14.50, in the unincorporated area west of the town of Boonville.

For this project, the County must acquire additional rights of way from Mendocino Redwood Company, LLC. DOT has obtained an Acquisition of Right of Way Agreement and Grant Deed executed by the property owner for the rights of way required. We now request the Board approve said Acquisition of Right of Way Agreement, DOT Agreement No. 180075, and accept the Grant Deed for the conveyance of real property to the County.


It is also recommended that the Board authorize and direct the Chair of the Board to execute the Statutory Certificate of Acceptance and direct the Clerk of the Board to submit the Grant Deed to the County Department of Transportation office for further processing and recording.

We have prepared a Resolution for your consideration, which will approve DOT Agreement No. 180075 and accept the Grant Deed with the property owner to acquire the necessary rights of way.

The Resolution authorizes the Chair of the Board to execute the document on behalf of the County.
