

**FIRST AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 18-078**

This Amendment to BOS Agreement No. 18-078 is entered into this 2nd day of October, 2018, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Kemper Consulting Group, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 18-078 was entered into on May 1, 2018; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Kemper Consulting Group, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the contract amount set out in the original BOS Agreement No. 18-078, by Twenty Eight Thousand Dollars (\$28,000) for a new not to exceed amount of Sixty Eight Thousand Dollars (\$68,000.)

NOW, THEREFORE, we agree as follows:

1. The original BOS Agreement No. 18-078, will be increased by Twenty Eight Thousand Dollars (\$28,000) for a new not to exceed amount of Sixty Eight Thousand Dollars (\$68,000).

All other terms and conditions of BOS Agreement No. 18-078 shall remain in full force and effect.
