Leadership

Open Enrollment

The annual Health Plan Open Enrollment period is October 16 through November 30, 2018. Employees enrolled in the Mendocino County health plan have one opportunity during the annual Open Enrollment period to make changes to their health plan benefits without experiencing a qualifying life event. The Open Enrollment Fairs kick off the Open Enrollment period. The fairs offer every employee an opportunity to speak face to face with various health and wellness vendors, get questions answered and sign up or renew their benefits. All forms regarding Open Enrollment and any changes to the employee's health plan must be received in the Human Resources Office by 5:00 p.m. on Friday, November 30, 2018. Health and Human Services Update

Safe Disposal of Medications and Sharps

Health and Human Services (HHSA) - Public Health and MendoRecycle are working together to safe-guard the environment and the community's health. Both County agencies want to help citizens dispose of medication and used syringes in a responsible way.

MendoRecycle received five free medicine collection bins from the California Product Stewardship Council and has been looking for suitable sites to place them. Sites are being identified in Ukiah, Fort Bragg, and the Hopland Reservation. They are still looking for additional sites, preferably in pharmacies.

Public Health is also offering communities throughout the County the opportunity to have needle drop boxes in their jurisdictions. Public Health will purchase the boxes, and is asking the cities to install them. Public Health is also working with community stakeholders to develop a primary needle exchange program that keeps used needles off the streets and offers addiction treatment opportunities.

Facilities Update – Completed Projects

Mendocino Substation

The Mendocino Substation at the Ford House Carriage House was completed September 28, 2018. The project involved removal of the existing building and re-construction of an identical building on a slab foundation to match the original carriage house from the exterior. The new interior includes workspace for Sheriff's Deputies and an entrance for the substation concealed behind replica carriage doors. The total project cost was \$255,000.





Little River Airport

The Little River Airport Terminal project was completed on June 30, 2018. The project included a new roof and exterior shell, including windows and doors. ADA parking and path of travel were included, along with new interior finishes, which includes a remodeled office space and pilot's area. The total project cost was \$290,000.

Emergency Projects

On September 21, 2018, the County was notified that PG&E had de-energized an electrical service line, owned by the County, which provides power to a repeater/communication site. Prior to PG&E re-energizing the line, they required that vegetation clearing and repairs be made. Based on an emergency declaration, the vegetation removal and repairs were completed and the line was re-energized on October 5, 2018. Necessary parts for the power line were not available from suppliers, and the City of Ukiah provided them under mutual aid.

On September 19, 2018, HHSA staff notified Facilities of a redwood tree located at a County owned facility at 1120 South Dora, Ukiah, which appeared dangerous. An arborist was requested to evaluate the tree, and the arborist determined that the tree has a high risk of failure. Based on an emergency declaration, a contractor has been scheduled to remove this tree as soon as possible.

Western Hills Fire Safety Project

The Western Hills Fire Safety Project represents a comprehensive approach to protecting the Ukiah Valley from a catastrophic fire. The County of Mendocino is working with CAL FIRE, the City of Ukiah, the Ukiah Valley Fire Authority, and the Mendocino County Fire Safe Council in this effort which includes a shaded fuel break at the base of the hills, ridgetop fire breaks, and vegetation management. It is anticipated that success in this effort will serve as a demonstration project to inspire similar comprehensive efforts for implementation in other Mendocino County communities. On October 4, 2018, Assembly Member Jim Wood met with the partners in this effort to learn about the effort and provide support. Participants from the County included Supervisor John McCowen, Chief Executive Officer, Carmel Angelo, and Deputy Chief Executive Officer, Steve Dunnicliff.

Income Statistics

- 19 feral cats received
- 28 owner surrendered animal(s) received
- 73 cats, 88 dogs, 0 livestock animal(s), two other stray type animal(s) received
- Four owned dogs received
- Five owned dogs & one owned cat received from law enforcement
- Eight dead animal(s) disposal request received
- 0 animal(s) for rabies specimen testing received
- 170 total animal(s) received

Outcome Statistics

September 1, 2018, through September 30, 2018:

- 22 dogs adopted
- 38 cats adopted
- 0 other animal(s) adopted
- 35 animals transferred to rescue organizations
- Nine feral cats trapped-neutered-released
- 48 animal(s) were returned to owners
- One owner-surrendered animal(s) euthanized
- Two cats died while receiving medical treatment/care
- Four shelter cats & 11 shelter dogs euthanized due to illness, disease or behavior
- 178 total animals outcomed
- Live release rate of approximately 91.5%
