#### 3665-18 11-21/18 SUMMARY OF PROPOSED ORDINANCE

AN ORDINANCE AMENDING CHAPTER 10A.17 MENDOCINO CANNABIS CULTIVATION ORDI-NANCE AND CHAPTER 20.242 CANNABIS CULTIVATION SITES OF THE MENDOCINO COUNTY CODE; ADDING CHAPTER 20.118 "CA" CANNABIS ACCOMMODA-TION COMBINING DISTRICT AND CHAPTER 20.119 "CP" COMMER-CIAL CANNABIS PROHIBITION COMBINING DISTRICT TO THE MENDOCINO COUNTY CODE; AND REZONING CERTAIN PARCELS TO APPLY THE CA AND CP COMBIN-ING DISTRICTS

ordinance This is making amendments to Chapters 10A.17 and 20.242 to provide additional flexibility for setbacks and lot sizes in the review of cannabis cultivation permits. The new Chapter 20.118 "CA" Cannabis Accommodation Combining District is intended to support con-tinued operation of existing cultivation sites and the new Chap-ter 20.119 "CP" Cannabis Prohibition Combining District is in-tended to prohibit new commercial cannabis uses and would sunset existing permitted commercial cannabis uses. Also proposed is the rezoning of parcels to establish (1) the first CA Combining Districts in the following areas: Covelo Covelo-Fairbanks Core. Road, Laytonville, and South Leggett; and (2) the first CP Combining Districts in the following areas: Deerwood and Boonville Road-Woodyglen.

The proposed ordinance is scheduled for adoption on December 4, 2018.
