

**RESOLUTION NO. 19-162**

**RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS REQUESTING THAT THE CALIFORNIA DEPARTMENT OF TRANSPORTATION GRANT ITS PERMISSION FOR THE COVELO FFA FIELD DAY PARADE IN COVELO PURSUANT TO THE DEPARTMENT OF TRANSPORTATION AND CALIFORNIA HIGHWAY PATROL'S JOINT POLICY GUIDELINES FOR SPECIAL EVENTS ON STATE CONVENTIONAL HIGHWAY RIGHTS-OF-WAYS**

WHEREAS, the Covelo FFA wishes to hold a parade in connection with their annual Mother's Day Weekend Field Day; and

WHEREAS, said parade will be held from 8:45 a.m. to 10:30 a.m. on May 11, 2019. Parade line up will begin on the corner of Main Street and Eberle Street and the parade will proceed east on Eberle Street until it meets Highway 162, where it will turn north, continue on Highway 162 until Howard Street, where it will turn west and proceed to the Round Valley High School; and

WHEREAS, in order for the parade to be held, the Covelo FFA needs to seek support from the Mendocino County Board of Supervisors, pursuant to the Department of Transportation and California Highway Patrol's Joint Policy Guidelines for Special Events on State Conventional Highway Rights-of-Ways to conduct a parade.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors does hereby support the Covelo FFA Field Day Parade and seeks the support and cooperation of any involved agencies.

BE IT FURTHER RESOLVED that the Mendocino County Board of Supervisors does hereby state that any liabilities and responsibilities shall rest with the parade sponsors.

BE IT FURTHER RESOLVED that the Mendocino County Board of Supervisors requests the California Department of Transportation to give its permission pursuant to the California Department of Transportation and California Highway Patrol's Joint Policy Guidelines for Special Events on State Conventional Highway Rights of Ways to the Covelo FFA to hold a parade on May 11, 2019, on Highway 162 in Covelo, California.

BE IT FURTHER RESOLVED that the Clerk of the Board of Supervisors is directed to forward copies of this Resolution to the California Department of Transportation District Permit Coordinator (Eureka), the California Highway Patrol, and the Covelo FFA.

The foregoing Resolution introduced by Supervisor McCowen, seconded by Supervisor Williams, and carried this 23 day of April, 2019, by the following vote:




