RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AMENDING THE FY 2018-19 ADOPTED BUDGET BY ADJUSTING REVENUES AND APPROPRIATIONS

WHEREAS, on June 19, 2018, the Board of Supervisors adopted Resolution No. 18-084 which adopted the FY 2018-19 County Budget, and as further amended on November 13, 2018 by adopting Resolution No. 18-171; and as further amended on March 26, 2019 by adopting Resolution No. 19-154; and

WHEREAS, Sections 29125, 29126, 29126.1 and 29130 of the Government Code provides authority for the Board of Supervisors to transfer and revise appropriations, cancel unused appropriations, transfer unused appropriations to contingencies, reduce revenue estimates and cancel and appropriate designations and reserves other than the general reserve; and

WHEREAS, revenue estimates and appropriations within the FY 2018-19 Budget have been reviewed and approved by the Chief Executive Officer and Auditor-Controller based on information which has become available since the time of adoption of the budget, and it is recommended that the Board of Supervisors approve certain revisions to the budget.

NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors that amendments to the Fiscal Year 2018-19 Adopted Budget of the County of Mendocino, as shown in Attachment A, entitled "FY 2018-19 3rd Quarter Budget Adjustments" are hereby ordered and approved.
