

**SEVENTH AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 11-008**

This Amendment to BOS Agreement No. 11-008 is entered into this 21st day of May, 2019, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Solid Wastes of Willits, Inc., hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 11-008 was entered into on January 25, 2011; and

WHEREAS, BOS Agreement No's 11-008 A1, 11-008 A2, 11-008 A3, 11-008 A4, 11-008 A5, and 11-008 A6 were entered into on November 15, 2011, January 24, 2012, January 22, 2013, May 17, 2016, July 18, 2017, and September 25, 2018; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Solid Wastes of Willits, Inc., this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, County of Mendocino ("County") and Solid Wastes of Willits, Inc. ("Grantee") entered into Caspar Transfer Station Operations Agreement and Lease between County of Mendocino and Solid Wastes of Willits, Inc. ("Agreement") for the Caspar Transfer Station, and Agreement was approved by the Board of Supervisors with the consent and concurrence of the City of Fort Bragg on January 28, 2011 (BOS Agreement #11-008); and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. 11-008, from June 30, 2017 to June 30, 2021; and

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original BOS Agreement No. 11-008 will be extended from June 30, 2017 to June 30, 2021.

All other terms and conditions of BOS Agreement No. 11-008, 11-008 A, 11-008 A2, 11-008 A3, 11-008 A4, 11-008 A5, and 11-008 A6 shall remain in full force and effect.
