WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original Agreement No. <u>18-134</u>, from <u>June 30,2020</u> to <u>June 30, 2021</u>; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the "not to exceed" value set out in the original BOS Agreement No. <u>18-134</u>, from <u>\$50,000</u> to <u>\$150,000</u>;

NOW, THEREFORE, we agree as follows:

- 1. The termination date set out in the original Agreement No. <u>18-134</u> will be extended from <u>June 30, 2020</u> to <u>June 30, 2021</u>.
- 2. The compensation payable in BOS Agreement No. <u>18-134</u> will be increased from a "not to exceed" value of \$50,000 to \$150,000.

All other terms and conditions of BOS Agreement No. <u>18-134</u> shall remain in full force and effect.
