

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 18-134**

This Amendment to BOS Agreement No. 18-134 is entered into this 16th day of July, 2019, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and DON Folsom, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 18-134 was entered into on 09/12/2018; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and CONTRACTOR, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original Agreement No. 18-134, from June 30, 2020 to June 30, 2021; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the "not to exceed" value set out in the original BOS Agreement No. 18-134, from \$50,000 to \$150,000;

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original Agreement No. 18-134 will be extended from June 30, 2020 to June 30, 2021.
2. The compensation payable in BOS Agreement No. 18-134 will be increased from a "not to exceed" value of \$50,000 to \$150,000.

All other terms and conditions of BOS Agreement No. 18-134 shall remain in full force and effect.
