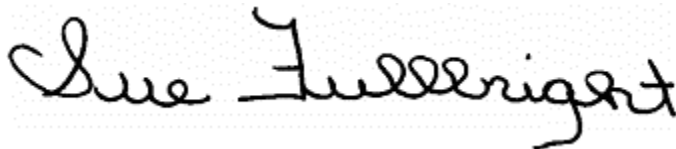

ORDINANCE NO. 4434

AN ORDINANCE CHANGING THE
ZONING OF REAL PROPERTY
WITHIN MENDOCINO COUNTY

The Board of Supervisors of the
County of Mendocino, State of
California, ordains as follows:

Section 1. Findings. Based on
the information provided in the
memorandum accompanying
this ordinance and evidence in
the record, the Board of Supervi-
sors makes the following find-
ings:

(a) The Project is Exempt
from CEQA pursuant to Section
15183 of the State CEQA Guide-
lines.

(b) The Project is located
within a Rural Residential Gen-
eral Plan Land Use Designation
and the site is consistent with
the minimum parcel size of 10
acres in the Rural Residential
(RR:10) zoning district.

(c) The Project meets the
stated intent and minimum lot
size requirements of the Rural
Residential (RR:10) zoning dis-
trict, as stated in Mendocino
County Code Chapter 20.048.

Section 2. Rezone. Pursuant to
Division I of Title 20, Chapter
20.212 of the Mendocino County
Code, the zoning of the follow-
ing real property within
Mendocino County is hereby
changed as follows:

Said zoning change encompass-
es a portion of Assessor Parcel
Number 163-082-09 and all of As-
sessor's Parcel Number 163-090-
05 which are reclassified from
Rural Residential (RR:1) to Rural
Residential (RR:10) as shown on
attached Exhibit A and describ-
ed in Exhibit B.

Passed and adopted by the
Board of Supervisors of the
County of Mendocino, State of
California, on this 16th day of Ju-
ly, 2019, by the following vote:
