

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 16-061 & 16-061-A1**

This Amendment to BOS Agreement No. 16-061 & 16-061-A1 is entered into this 6th day of August, 2019, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and Deborah Yacobellis, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 16-061 was entered into on 07/19/2016; and

WHEREAS, BOS Agreement No. 16-061-A1 was entered into on 06/19/2018 to extend the termination date set out in the original BOS Agreement No. 16-061, from 06/30/2018 to 06/30/2019; and

WHEREAS, BOS Agreement No. 16-061-A1 was entered into on 06/19/2018 to increase the "not to exceed" value set out in BOS Agreement No. 16-061, from \$90,000 to \$115,000; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and Deborah Yacobellis, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in BOS Agreement No. 16-061-A1, from 06/30/2019 to 06/30/2020; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the "not to exceed" value set out in BOS Agreement No. 16-061-A1, from \$115,000 to \$140,000; and

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original BOS Agreement No. 16-061 & 16-061-A1 will be extended from June 30, 2019 to June 30, 2020.
2. The compensation payable in BOS Agreement No. 16-061 & 16-061-A1 will be increased from a "not to exceed" value of \$115,000 to \$140,000.

All other terms and conditions of BOS Agreement No. 16-061 & 16-061-A1 shall remain in full force and effect.
