




Current and Future State

Number of Failures 2017 -2019




# System Needs

Necessary Improvements

#### System Wide Needs

- All Microwave, Radios and Repeaters *End of Life mid-2020* 
  - Spare parts are difficult to obtain
- Dispatch Console End of Life
- 90% of Patrol car radios End of Life
- Additional Resiliency needed in coastal areas
- Significant Facilities needs countywide
  - Facility cooling/heating
  - Generators
  - Electrical
  - Tower inspections
  - Dispatch basement suitability issues



#### Microwave Resiliency Needs




- Current Microwave
   Communication does not provide adequate redundancy
- Creates a reliable and redundant radio communication network
- Improved resiliency in the event of disaster
- Close Fort Bragg loop

#### **Sheriff Dispatch Console**

- Equipment installed in 1990
- Antiquated technology
- All components End of Life
  - No support & replacement parts almost impossible to locate.






#### Severe Weather Conditions





### Significant Facilities Needs



#### Significant Facilities Needs

- Structure
   Replacement/Repair/
   Maintenance
  - Cooling
  - Electrical
  - Roof replacements/sealing
  - Water penetration
    - Equipment requires protective tarps
  - Sanhedrin power lines
  - Dispatch basement not suitable for equipment



#### Significant Facilities Needs

- Generator Upgrades Needed
  - 6 sites running residential grade generators
  - Delays in getting emergency operations areas up and running in the event of an emergency due to power outages
- UPS Replacements
  - Power Failure can result in loss of legacy equipment












#### **Estimated Costs**

Repeaters Phase 1	Replace and improve communication stability and resiliency	\$1,600,500
Microwave and Switching - Phase 2	Network speed increases by 3x over the current speed to meet demands	\$4,000,000
Dispatch Console	Console upgrade and ongoing support	\$1,000,000
Sheriff's Patrol Car Radios		\$250,000

Point Arena	Remaining costs after \$250k equipment funding grant applied – Deadline for completion Apr-2020	\$375,000
Fort Bragg	Close the loop to add redundancy	\$1,000,000
Facilities		
Generator Upgrades		\$590,000
HVAC/Power	*Need to obtain cost estimates	\$500,000
Buildings	*Need to obtain cost estimates	\$1,500,000
Replace 7 miles of power poles to Sanhedrin	*Need to obtain cost estimates	\$500,000


