WHEREAS, it is the desire of CONTRACTOR and COUNTY to increase the total compensation payable set out in the original BOS Agreement No. 17-036 & BOS 17-036-A1, from one hundred and fifty thousand dollars (\$150,000) to one hundred and seventy thousand dollars (\$170,000); and

NOW, THEREFORE, we agree as follows:

1. The compensation payable to CONTRACTOR set out in the original BOS Agreement No. <u>17-036 & BOS 17-036-A1</u> will be increased from <u>\$150,000.00</u> to <u>\$170,000.00</u>.

All other terms and conditions of BOS Agreement No. <u>17-036 & BOS 17-036-A1</u> shall remain in full force and effect.
