

RESOLUTION NO. 19-393

RESOLUTION OF THE MENDOCINO COUNTY BOARD OF SUPERVISORS AUTHORIZING THE BEHAVIORAL HEALTH AND RECOVERY SERVICES DIRECTOR OF THE HEALTH AND HUMAN SERVICES AGENCY TO SIGN AS AN AGENT ON BEHALF OF THE COUNTY OF MENDOCINO FOR THE STATE OF CALIFORNIA, DEPARTMENT OF HEALTH CARE SERVICES, AGREEMENT NUMBER 18-95255 (PERFORMANCE CONTRACT)

WHEREAS, the Board of Supervisors of the County of Mendocino (hereinafter "Board") has read the proposed Agreement between the California Department of Health Care services (hereinafter "DHCS") and the Mendocino County Health and Human Services Agency Behavioral Health and Recovery Services, Agreement Number 18-95255 (hereinafter "Agreement"); and

WHEREAS, the Board acknowledges the benefits and responsibilities to be shared by both parties to said Agreement; and

WHEREAS, DHCS administers the Mental Health Services Act, Lanterman-Petris-Short (LPS) Act, Projects for Assistance in Transition from Homelessness (PATH), Community Mental Health Services Block Grant (MHBG), and Crisis Counseling Assistance and Training Program and oversees county provision of community mental Health services provided with realignment funds; and

WHEREAS, Mendocino County must meet certain conditions and requirements to receive funding for these programs and community mental health services; and

WHEREAS, said agreement is the County's performance contract, as required by Welfare and Institutions Code sections 5650(a), 5651, 5666, 5897, and Title 9, California Code of Regulations, section 3310, setting forth conditions and requirements that Mendocino County must meet in order to receive this funding, and certifying that the County will comply with said conditions and requirements.


NOW, THEREFORE, BE IT RESOLVED that the Mendocino County Board of Supervisors hereby authorizes the Mendocino County Health and Human Services Agency Behavioral Health and Recovery Services Director to sign and execute said Agreement and any amendments thereto that do not increase the maximum total dollar amount of the Agreement.

The foregoing Resolution introduced by Supervisor McCowen, seconded by Supervisor Williams, and carried this 10th day of December, 2019, by the following vote:






