

AMENDMENT OF MENDOCINO
COUNTY CODE SECTION 5.130.010
DELEGATING AUTHORITY TO IN-
VEST TO COUNTY TREASURER
FOR CALENDAR YEAR 2020

The Board of Supervisors of the
County of Mendocino ordains as
follows:

Section 5.130.010 is amended to
read as follows:

Section 5.130.010 Delegation of Authority to Invest for Calendar Year 2020

"Pursuant to authority con-
tained in Government Code sec-
tion 27000.1 and 53607 the Board
of Supervisors hereby delegates
to the Treasurer the authority to
invest or reinvest the funds of
the County and the funds of oth-
er depositors in the County
Treasury pursuant to Govern-
ment Code sections 53600 to
53970 for calendar year 2020.
Nothing in this section shall lim-
it the Treasurer's authority pur-
suant to Government Code sec-
tions 53635 or 53684."

The proposed ordinance is
scheduled for adoption on Tues-
day, February 4, 2020.
