RE: ADOPTION OF RESOLUTION AUTHORIZING THE **DEPARTMENT** OF TRANSPORTATION TO ADVERTISE FOR BIDS AND AWARD THE DEPARTMENT OF TRANSPORTATION CONTRACT NUMBER 200001 FOR CONSTRUCTION OF THE REDWOOD VALLEY WATER INFRASTRUCTURE RETROFIT PROJECT, AT AN ESTIMATED COST OF \$6,200,000 (REDWOOD VALLEY AREA)

Honorable Board Members:

The Mendocino County Department of Transportation (DOT) Contract Number (No.) 200001 provides for the construction of the Redwood Valley Water Infrastructure Retrofit Project on behalf of the Redwood Valley County Water District (RVCWD). The County of Mendocino has standing to obtain Redwood Fire Disaster Hazard Mitigation Grant Programs (HMGP) funding and to administer these funds to accomplish needed construction under this contract.

This project is attempting to mitigate seismic hazards currently threatening RVCWD infrastructure. The expected outcome is the replacement of approximately 10,577 feet of existing water main lines, installation of approximately 3,300 feet of new water main lines where necessary, and replacement of up to 146 water service lateral connections; providing current code and standards water flows and pressures to existing RVCWD customers within the 2017 fire area.

RVCWD infrastructure, if subjected to a sufficiently large seismic event, could suffer significant damage to the system. Replacing existing water main lines with modern, seismically-rated polyvinyl chloride (PVC) main lines, including restrained joint design, modern backfill procedures, and a more robust system of valves to allow for isolating portions of the water distribution system for repair, will introduce a much larger degree of resiliency to the system.

Brelje & Race Consulting Engineers under Phase 2 of BOS Agreement No. 19-004/DOT Agreement No. 180073 will perform the required construction support work for \$543,500 within the total contract not-to-exceed amount of \$1,201,500.
