

**AMENDMENT TO BOARD OF SUPERVISORS
AGREEMENT NO. 19-131**

This Amendment to BOS Agreement No. 19-131 is entered into this 25th day of February 2020, by and between the COUNTY OF MENDOCINO, a political subdivision of the State of California, hereinafter referred to as "COUNTY" and LACO Associates, hereinafter referred to as "CONTRACTOR".

WHEREAS, BOS Agreement No. 19-131 was entered into on May 8, 2019; and

WHEREAS, upon execution of this document by the Chair of the Mendocino County Board of Supervisors and LACO Associates, this document will become part of the aforementioned contract and shall be incorporated therein; and

WHEREAS, it is the desire of CONTRACTOR and COUNTY to extend the termination date set out in the original BOS Agreement No. 19-131, from December 31, 2019 to March 31, 2020; and

NOW, THEREFORE, we agree as follows:

1. The termination date set out in the original BOS Agreement No. 19-131 will be extended from December 31, 2019 to March 31, 2020.

All other terms and conditions of BOS Agreement No. 19-131 shall remain in full force and effect.
