Notice of Public Hearing for Discussion of Possible State CDBG Application

NOTICE IS HEREBY GIVEN that the Mendocino County Board of Supervisors will conduct a public hearing on **Wednesday, June 8, 2022 at 9:00 AM** or as soon thereafter as the item may be considered, in order to discuss possible applications for funding under the next fiscal year's State Community Development Block Grant (CDBG) Program and to solicit public input on possible activities to be included in the application. This meeting will be held in the Board of Supervisors Chambers, 501 Low Gap Road, Ukiah, California, and virtual attendance will be available via Zoom (pursuant to Government Code section 54953(e)(1)(A)). Meetings are live streamed and available for viewing on the Mendocino County YouTube page, at <https://www.youtube.com/MendocinoCountyVideo> or by toll-free, telephonic live stream at 888-544-8306.

The Community Development and Economic Development Allocations of the State CDBG program publish a combined "Notice of Funding Availability" (NOFA) each program year. Eligible cities and counties may submit applications for CDBG funds under the NOFA for a maximum per application request of \$1,500,000. It is estimated that the funding of the State 2022 CDBG program allocation is approximately \$30,000,000.

ELIGIBLE ACTIVITIES UNDER THE ABOVE ALLOCATIONS IN THE NOFA MAY CONSIST OF: PLANNING AND TECHNICAL ASSISTANCE, AND ECONOMIC DEVELOPMENT PROJECTS AND PROGRAMS. THERE WILL BE **NO** MULTIFAMILY HOUSING, HOUSING INFRASTRUCTURE, AND COMMUNITY DEVELOPMENT PROJECT FUNDING IN THIS NOFA.

THE MAXIMUM AWARD FOR PLANNING AND TECHNICAL ASSISTANCE IS \$250,000, AND THE MAXIMUM AWARD FOR ECONOMIC DEVELOPMENT IS \$750,000.

The County of Mendocino anticipates submitting an application under the NOFA published during the next program year. The County has or anticipates receiving approximately \$ 120,000.00 in CDBG Program Income that must be expended prior to expending awarded grant funds. In order to meet this requirement, the County has established a Revolving Loan Fund to assist small businesses with the impacts of COVID-19.

All persons are invited to appear and present testimony in this matter. Oral comments may be presented to the Board of Supervisors during the public hearing.

In order to minimize the risk of exposure during this time of emergency, the public may participate digitally in meetings in lieu of personal attendance.
