

## RESOLUTION NO. 22-132

### **A RESOLUTION APPROVING AN APPLICATION TO THE 2022 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM FOR FUNDING AND THE EXECUTION OF A GRANT AGREEMENT AND ANY AMENDMENTS THERETO FROM THE 2022 NOFA DATED APRIL 19, 2022**

BE IT RESOLVED by the County of Mendocino Board of Supervisors as follows:

#### **SECTION 1:**

The County Board of Supervisors has reviewed and hereby approves the submission to the State of California of one or more application(s) in the aggregate amount, not to exceed, of \$750,000 for the following CDBG activities, pursuant to the April 2022 CDBG NOFA:

#### **Activities**

Economic Development- Planning and Technical Assistance Master Environmental Studies in the Noyo Harbor to promote Economic Stability	\$250,000
Microenterprise Technical Assistance	\$500,000

#### **SECTION 2:**

No use of Program Income Funds is requested.

#### **SECTION 3:**

The County acknowledges compliance with all state and federal public participation requirements in the development of its application(s).

#### **SECTION 4:**

The County hereby authorizes and directs the Director of Planning and Building Services or designee, to execute and deliver all applications and act on the County's behalf in all matters pertaining to all such applications.

#### **SECTION 5:**

If an application is approved, the Director of Planning and Building Services, or designee, is authorized to enter into, execute and deliver the grant agreement (*i.e.*, Standard Agreement) and any, and all subsequent amendments thereto with the State of California for the purposes of the grant.

#### **SECTION 6:**




