Servicios de Recuperación y Salud Conductual

Mes de Concientización sobre el Trastorno de Estrés Postraumático

El PTSD ocurre en personas después de haber experimentado un evento particularmente traumático como la guerra, agresión física/sexual/verbal violenta, accidentes, etc. Los síntomas incluyen depresión, ansiedad, pesadillas, paranoia, insomnio, pensamientos perturbadores y mucho más. Muchas personas se recuperan del PTSD después de unos días, semanas o meses. Sin embargo, para otros, el camino de la recuperación puede significar un año o más. El PTSD es altamente tratable, pero debido a la falta de conocimiento al respecto, así como al estigma asociado a la búsqueda de ayuda mental, muchos optan por ignorar el problema y sufrirlo. Junio es el Mes de Concientización sobre el PTSD. Ayúdenos a correr la voz de que existen tratamientos efectivos para el PTSD. CalOES Destinatario de la Moneda del Desafío

Nos gustaría felicitar al coordinador de operaciones de campo de recuperación, Travis Killmer, por recibir una moneda de desafío de CalOES por su trabajo relacionado con la recuperación del incendio Hopkins. Travis ha estado trabajando en colaboración con el estado desde Noviembre 2021 en las operaciones consolidadas de remoción de escombros de la Fase 2 y ayudando al estado a desarrollar un proceso simplificado para que los sobrevivientes de incendios se inscriban en el proceso de Derechos de entrada. Esta moneda raramente se otorga a personas ajenas a CalOES.



Prevención, Recuperación, Resiliencia y Mitigación

El 1 de Junio de 2022, CAL FIRE anunció solicitudes exitosas por \$188 millones en proyectos locales de prevención de incendios forestales para las subvenciones de prevención de incendios forestales 2021-22. De los 144 proyectos locales de prevención de incendios forestales financiados en todo el estado, se aprobó la financiación de cuatro proyectos en el condado de Mendocino. El Proyecto de Preparación Comunitaria y Reducción de Combustibles del Condado de Mendocino de PRRM recibió \$ 1,894,185, la Banda de Indios Pomo de Sherwood Valley recibió \$ 138,987 para su Plan de Prevención de Incendios Forestales Tribales de Sherwood Valley, la Tribal Indígenas de Round Valley recibieron \$303,674 para su Proyecto Murphy Ridge Fuel Break - Fase 1, y el Consejo de Seguridad contra Incendios del Condado de Mendocino recibió \$2,522,335 para su Proyecto de Entrada/Salida de la Comunidad de Mendocino.

El Proyecto de Reducción de Combustibles y Preparación Comunitaria del Condado de Mendocino de PRRM es un proyecto multifacético que implementará la reducción de combustibles en las carreteras en ubicaciones clave en las áreas de Covelo y Laytonville, financiará el programa existente de Días de Astilladora Comunitaria del Condado de Mendocino por otros tres años, desarrollará un diseño preliminar para una ruta de evacuación de emergencia que sirve a tres subdivisiones de acceso único al este de Ukiah en la WUI: Deerwood Estates, El Dorado Estates y Vichy Springs y Guidiville Rancheria, y completar el análisis CEQA para cinco futuros proyectos de reducción de combustibles para optimizar y acelerar futuras actividades de implementación. Las áreas para el futuro análisis de CEQA son Branscomb Road, Old River Road, Redwood Ridge Road, Black Bart Trail y un descanso de combustible con sombra en las colinas del oeste de Hopland.

En total, este proyecto llevará a cabo un análisis CEQA y tratará 66.2 acres protegiendo 100-150 estructuras en Laytonville y Covelo, llevará a cabo un análisis CEQA para el futuro tratamiento de combustibles en aproximadamente 207 acres adicionales alrededor del Condado, atenderá a aproximadamente 4500 propietarios individuales para apoyar el establecimiento y mantenimiento de espacio defendible a través de 450 días de astillado comunitario, y proteger 325 hogares mediante la planificación de una ruta de evacuación alternativa en las colinas al este de Ukiah.

Behavioral Health and Recovery Services (BHRS) Update June 2022

June is Post-Traumatic Stress Disorder (PTSD) Awareness Month

PTSD occurs in people after they have experienced a particularly traumatic event like war, violent physical/sexual/verbal assault, accidents, and so forth. Symptoms include depression, anxiety, nightmares, paranoia, insomnia, disturbing thoughts, and much more. Many people recover from PTSD after a few days, weeks, or months. Yet, for others, the recovery road might mean one year or more. PTSD is highly treatable, but due to the lack of knowledge around it as well as the stigma attached to seeking mental help, many choose to ignore the problem and suffer through it. June is PTSD Awareness Month. Help us spread the word that effective PTSD treatments are available. BHRS:

- **Mental Health & Mental Health Services Act Programs** - May is Mental Health Month events were a huge success. We got lots of feedback at the Farmer's Markets and other events and look forward to incorporating that feedback as we move forward into a new fiscal year. It was very good to be back at in-person events sharing resources on Behavioral Health Services. Awareness-raising activities will continue throughout the year. Look for our new billboards on Northbound HWY 101 between the Talmage and Burke Hill offramps, near the Plant Road overcrossing. Mental Health meetings have begun to move into hybrid meetings utilizing both in-person and virtual meeting platforms. We hope this model will allow for more stakeholders to participate in meetings and provide input and feedback on our work for the mental health of our community. We will have a booth at the June 24th Fentanyl Awareness day event.
- **Mental Health Student Services Act (MHSSA)** - We held an open forum on May 16th and received updates on the services being provided. We are looking forward to finishing this school year and coordinating with providers and schools for the next school year.

Measure B:

- **Mobile Crisis Response** - Three full-time staff responding seven days a week, 8 am - 6:30 pm. The newest Mental Health Rehabilitation Specialist will be responding to North County and the Coast MCSO regions. We received positive feedback on a recent crisis response.
- **Crisis Residential Treatment** - Phoenix House is open and operational and has been receiving clients. Clients must be referred through Redwood Community Crisis Services for crisis prevention or stepdown. Phoenix House provides 30-days of crisis residential treatment. To date, the facility has served 7 individuals.
- **Community Education, Awareness, & Stigma Reduction** - NAMI leaders and Behavioral Health representatives continue to meet with local tribal leaders from across the County to determine how we can best be of assistance to each community. NAMI continues involvement with harm reduction and the Safe RX Coalition, including preparation for a Fentanyl awareness day taking place on June 24. NAMI leaders are continuing development on several projects aimed at reducing mental health stigma Countywide, including the production of a podcast, participation in California's Adopt a Highway program and construction of a community education campaign.
- **Behavioral Health Regional Training Center** - The Behavioral Health Regional Training Center now has a direct email address: BHTrainingCenter@mendocinocounty.org. Community members are encouraged to contact BHTrainingCenter@mendocinocounty.org for booking availability and general inquiries.
- **Psychiatric Health Facility (PHF)** - Nacht & Lewis, AECOM, and county staff have been meeting regularly on the demolition, construction, and programming requirements for the PHF at Whitmore Lane.

Substance Use Disorder Treatment (SUDT):

- Behavioral Health and Recovery Services Substance Abuse Disorder Treatment (SUDT) is partnering with Safe Rx Mendocino in sponsoring a Fentanyl Safety Awareness Day. The free event takes place from 9 a.m. – 4:30 p.m. Friday, June 24, 2022, at the Ukiah Fairgrounds, Carl Purdy Hall. Doctor Shannon Robinson from HMA will be a guest speaker. There will be several other guest speakers throughout the day. Lunch will be served. There are 12 programs signed up for tables to speak with anyone needing help, or information. Safe Rx. will be training people on how to use Narcan. SUDT, URC, BHRS, MCAVHN, Mendocino Coast clinic, Adventist Health, Mendonoma Health Alliance, New Life clinic, Public Health of Mendocino County, Arbor Youth Resource Center, and NAMI all have reserved tables to help those in need, or family members seeking help for their loved ones. Community Wellness:

- BHRS Community Wellness received Elevate Youth funding to expand substance use prevention youth leadership in outlying areas: Round Valley, Point Arena, and Anderson Valley. The staff will develop culturally responsive programs and resiliency and healing centered for youth, focusing on substance use prevention. Staff are attending technical assistance trainings and have reached out to Anderson Valley High School so far.
- The Queer Prom was a success, with over 116 youth in Mendocino County attending, including a drag show, talent show, and comedy show. The event was open to all students, and attendees were invited to dress up according to the “Enchanted Fairies” theme. Organized by the LGBTQ2S+ Friday Night Live (FNL) chapter and the Arbor Youth Resource Center, the event inspired enchanted fairy decoration, as well as local resource tables. The prom also had a photo booth, finger foods, and soft drinks/water.
- The LGBTQ2S+ FNL meets on Wednesdays from 3:30-5 pm at the Arbor Youth Resource Center, Ukiah. The chapter has changed its club name to Sexuality and Gender Alliance (SAGA). Their focus is on promoting an inclusive community for LGBTQ2S+ identifying youth and allies, including a welcoming space for anyone.

Grants:

- Presently Behavioral Health and Recovery Services is working on a grant to expand our electronic health records system to improve the efficiency of comprehensive care for our clients. Additionally, we are carefully reviewing other potential grant options to enhance or expand our services wherever we can.

Recent Grants Applied For:

- We are still awaiting notification about grants supporting COVID mitigation efforts and funding extensions for our SafeRX Mendocino program. Currently, we are working hard to put in motion our recently funded mentored internship program and projects funded by the Elevate Youth CA grant.

BHRS:

- **Ley de Servicios de Salud Mental (MHSA) y Salud Mental** - Los eventos de mayo, el Mes de la Salud Mental, fueron un gran éxito. Recibimos muchos comentarios en Farmer's Markets y otros eventos y esperamos incorporar esos comentarios a medida que avanzamos en un nuevo año fiscal. Fue muy bueno estar de regreso en los eventos en persona compartiendo recursos sobre los Servicios de Salud del Comportamiento. Las actividades de sensibilización continuarán durante todo el año. Busque nuestras nuevas carteleras publicitarias en HWY 101 en dirección norte entre las rampas de salida de Talmage y Burke Hill, cerca del cruce de Plant Road. Las reuniones de salud mental han comenzado a convertirse en reuniones híbridas que utilizan plataformas de reuniones virtuales y en persona. Esperamos que este modelo permita que más partes interesadas participen en las reuniones y brinden información y comentarios sobre nuestro trabajo para la salud mental de nuestra comunidad. Tendremos un puesto en el evento del día de concientización sobre el fentanilo el 24 de junio.
- **Ley de Servicios de Salud Mental para Estudiantes (MHSSA)** - Realizamos un foro abierto el 16 de mayo y recibimos actualizaciones sobre los servicios que se brindan. Esperamos terminar este año escolar y coordinar con los proveedores y las escuelas para el próximo año escolar.

Comité de Supervisión Ciudadana de la Ley de Tratamiento de Salud Mental (Measure B):

- **Respuesta Móvil a Crisis** - Tres miembros del personal de tiempo completo que responden los siete días de la semana, de 8 am a 6:30 pm. El especialista en rehabilitación de salud mental más nuevo responderá a las regiones del norte del condado y la costa de MCSO. Recibimos comentarios positivos sobre una respuesta reciente a la crisis.
- **Centro de Tratamiento Residencial de Crisis** - Phoenix House está abierta y operativa y ha estado recibiendo clientes. Los clientes deben ser referidos a través de Redwood Community Crisis Services para prevención de crisis o reducción. Phoenix House proporciona 30 días de tratamiento residencial de crisis. Hasta la fecha, la instalación ha atendido a 7 personas.
- **Educación comunitaria, concientización y reducción del estigma** - Los líderes de NAMI y los representantes de salud conductual continúan reuniéndose con líderes tribales locales de todo el condado para determinar cómo podemos ayudar mejor a cada comunidad. The water supply for Mendocino County water right holders in the Russian River is once again at high risk for 2022. The water supply is already stressed due to drought conditions, causing the ground and air to be “thirstier” and requiring more irrigation for crops, trees, and other vegetation. However, the Russian River is dependent on an inter-basin transfer of water from the Eel River to the East Fork Russian River above Lake Mendocino through the Potter Valley Project. This diversion is operated by PG&E to produce power, meet contractual obligations with Potter Valley Irrigation District, and maintain required flows in the East Fork RR. The power generation plant is offline due to mechanical failure with repairs taking 1-2 years and PG&E has filed a request to lower the East Fork flows similar to the level of 2021 when a person could step over the River where it met Lake Mendocino.

This reduction request was unexpected by the State Water Resources Control Board and RR stakeholders who have spent almost two years working toward a voluntary program to provide an alternative to complete restriction of water rights. The State Water Board approved the Voluntary Water Sharing Agreement Program at the June 7, 2022 Board meeting but all wait as the Federal Energy Regulatory Commission (FERC) considers PG&E’s request. If the variance is approved without modification, almost all water rights in the Upper Russian River (from Healdsburg north) will be cut off from use, or “curtailed.” This will impact agriculture, industry, and urban water uses including domestic and commercial. The State has gone to lengths to reserve sufficient supply to meet human health and safety quantities for domestic users and urban water suppliers at a 55 gallons per capita per day amount. Some water users and all urban water suppliers have an alternative water supply through groundwater or a contract with Russian River Flood Control District to access stored water in Lake Mendocino.

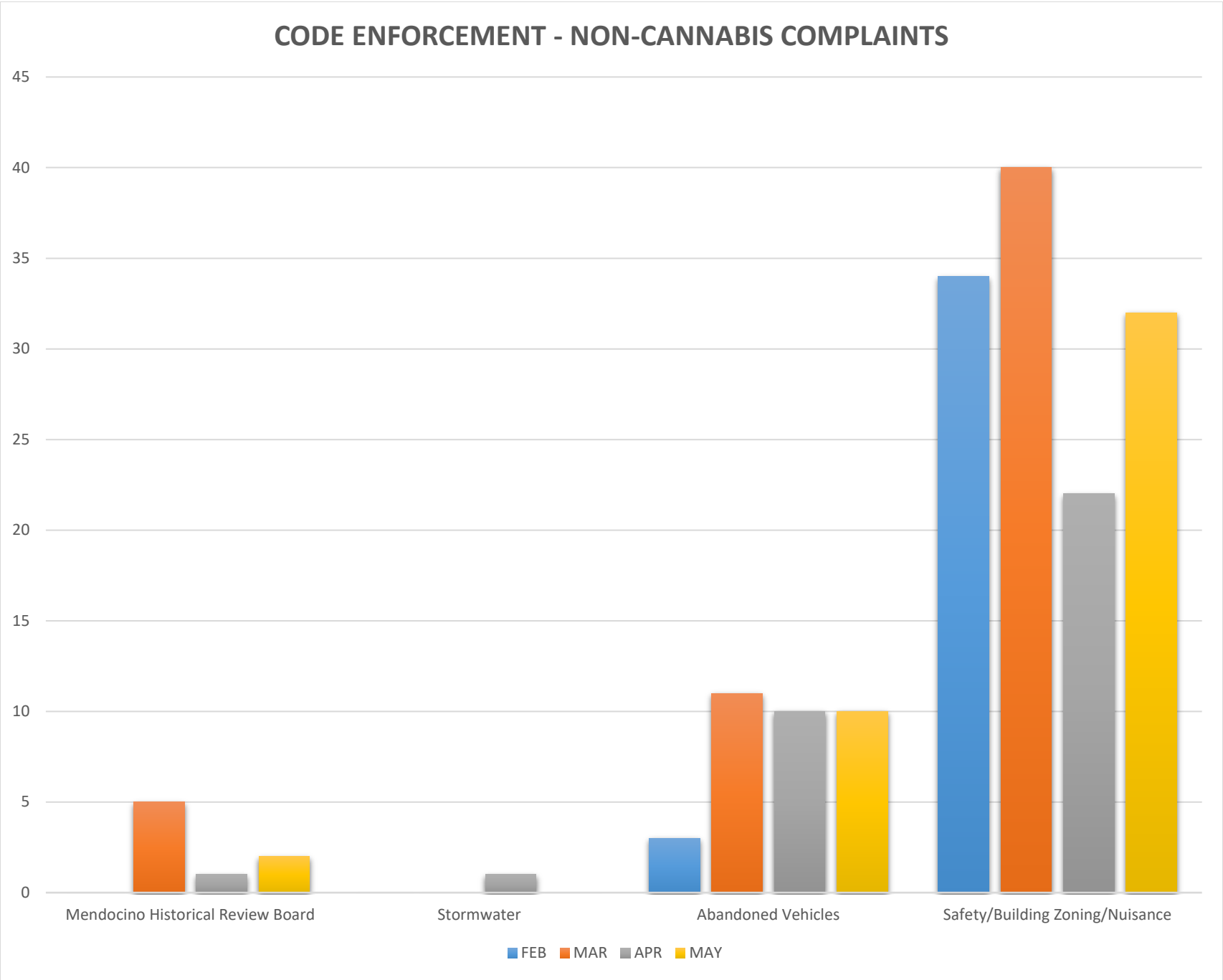
Lake Mendocino storage levels have increased approximately 2,000 acre feet in the last four weeks. This is an improvement to 2021 levels, however, the Lake levels are projected to fall to 2020 levels by October and without ample winter rains, the needle for reservoir recovery may not move much.

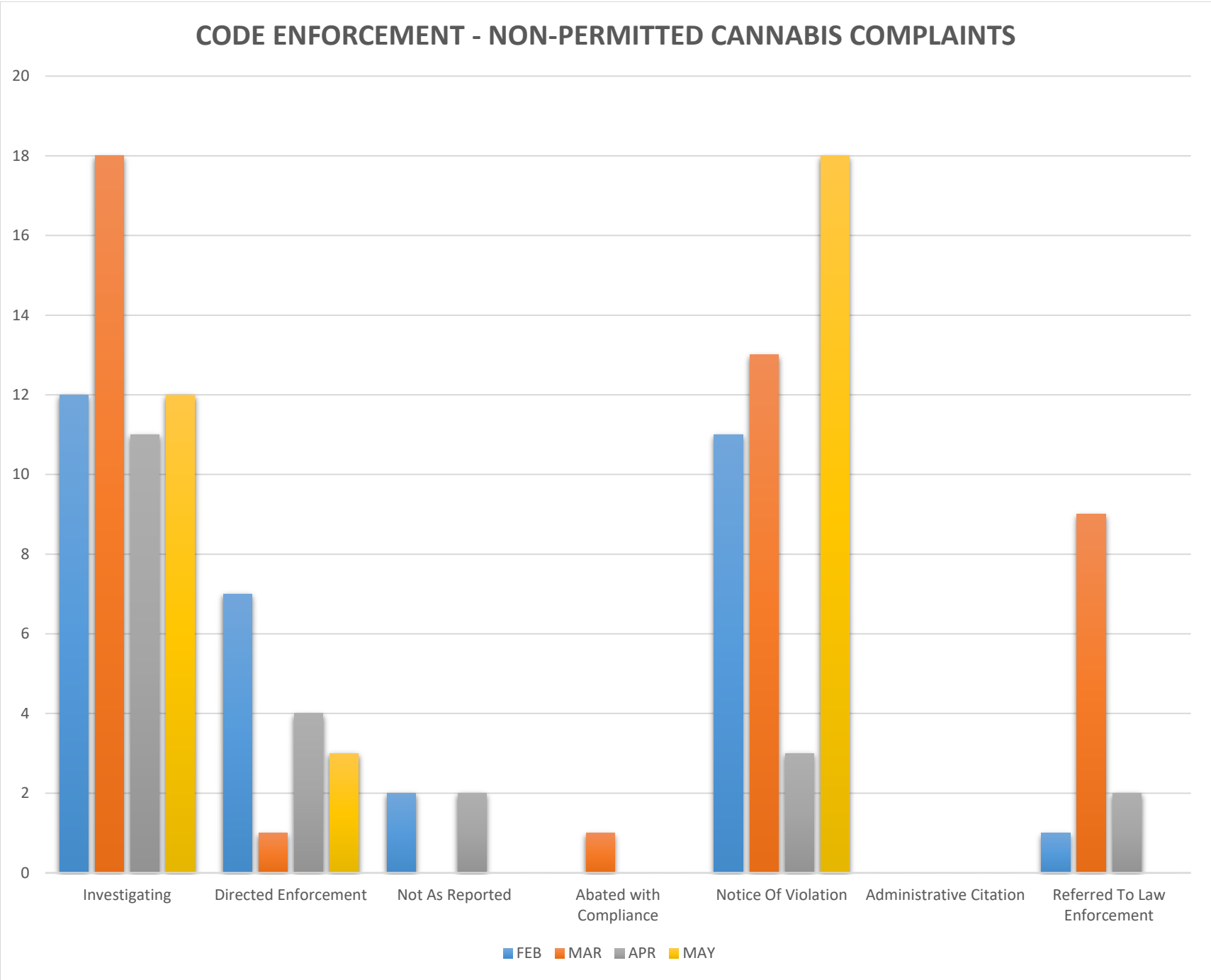
Water leaders and managers in the Russian River continue to build cooperative partnerships in several areas through the RR Drought Response Group, Groundwater Sustainability Agency, Inland Water & Power Commission, and a budding effort to implement grant funding for a Russian River Water Users Forum. The Upper Russian River Water Agency (URRWA) Joint Powers Agency and the City of Ukiah are exploring options for consolidation of services and governance with the State Water Resources Control Board providing support and, potentially, funding.

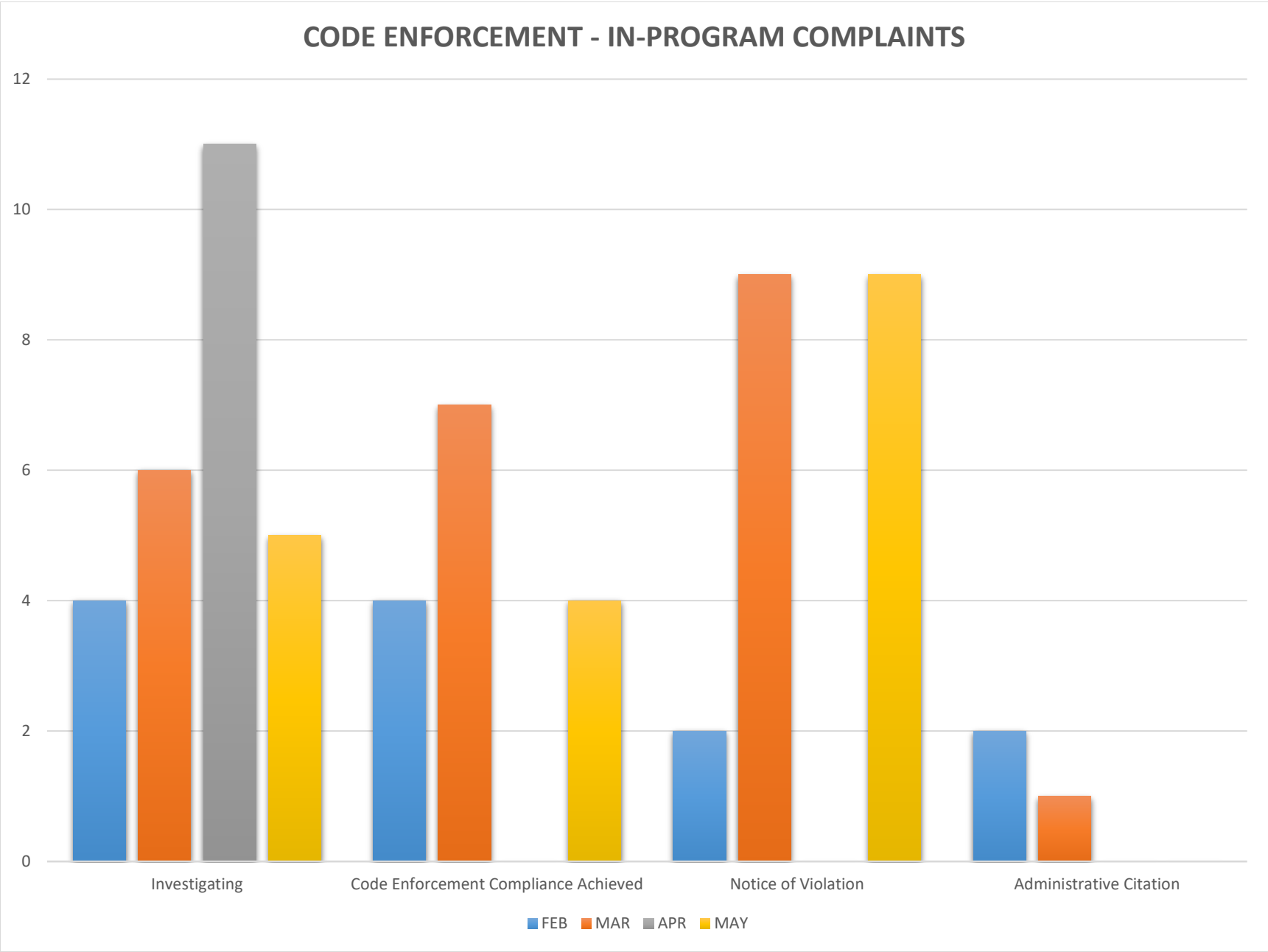
Statewide conservation efforts are underway with guidance and restrictions from both Governor Newsom and the State Water Board. All water users are requested to reduce water use by at least 20% and Emergency Water Conservation Regulations are in place providing strict limitations on water use for non-functional turf, water waste, etc.

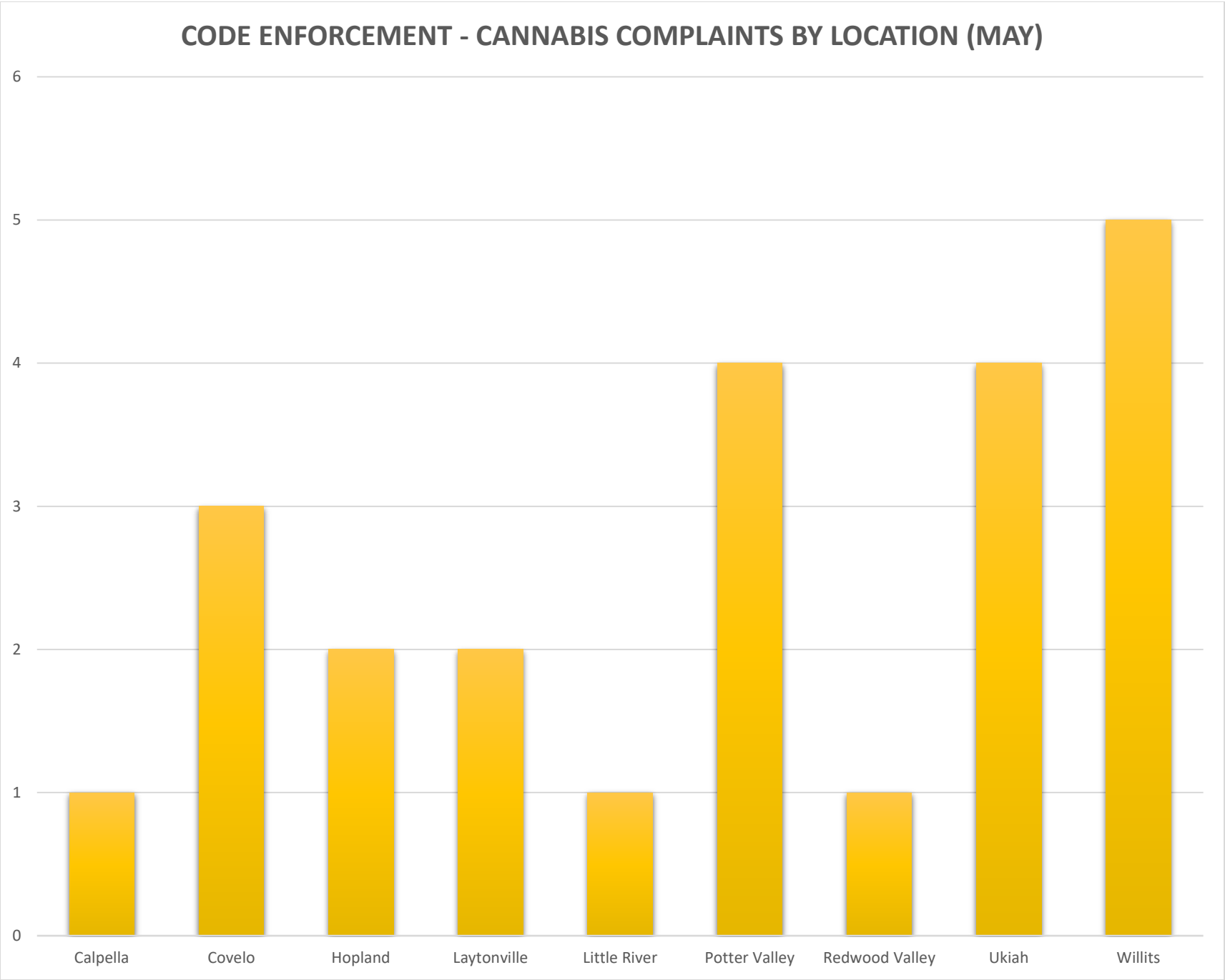

Director's Report – June 6, 2022

- **Solid Waste Franchise Area #2 Service Provider Transition:** The transition to solid waste collection services in Solid Waste Franchise Area #2 by Redwood Waste Solutions is quickly approaching. Solid Waste Franchise Area #2 includes customers currently served by Waste Management in the unincorporated Ukiah area, including Hopland, Redwood Valley, Potter Valley and surrounding areas, and the unincorporated Fort Bragg area, including Mendocino and surrounding areas. MCDOT has been meeting biweekly with Redwood Waste Solutions to plan for the transition. Between now and June 30th, public announcements and communications with individual customers are being sent out. The Ukiah customer service center is located at 3515 Taylor Drive and the Fort Bragg customer service center is located at 325A, E. Redwood Avenue. Customers who would like to contact Redwood Waste Solutions can do so by calling (707) 234-6400. Additionally, in the weeks leading up to the July 1st transition, customers will be delivered new containers and the old containers will be collected. Although we anticipate this transition to go smoothly, as with any large change, there may be issues that arise. MCDOT and Redwood Waste Solutions will be prepared to respond to any customer concerns. Our goal is to complete the transition without any service disruptions.
- **South Coast Landfill Closure Project Construction Project:** Pursuant to Board Resolution No. 22-052 (March 1, 2022), bids for Department of Transportation Contract No. 220001, South Coast Landfill Closure Construction Project were opened as scheduled on Thursday, April 21, 2022. REGE Construction of Cloverdale, California, was deemed the apparent "low bidder" for this project with a bid of \$4,700,880.00. The Engineer's Estimate for the contract was \$3,434,300.00. Due to budgetary constraints, all bids for the project were rejected.
- **Update on the Re-established Water Agency:** Subject to final Board direction, staff, based on results of the stakeholder surveys and key interviews, and with input from the Steering Committee, have prepared a phased staffing plan for the initial three years of a stand-alone County Water Agency.

The plan initially proposed the initial hiring of a General Manager and a Department Analyst in the first year, with an experienced technical professional (hydrologist/hydrogeologist/water resources engineer) added in the second year. However, due to extraordinary economic challenges, a longer than three year "ramp up" to a fully independent water agency is now anticipated. The Steering Committee and staff believe it is best to start with a single Water Agency employee as the "face" of the new Mendocino County Water Agency - to provide stability and recognition. The staffing plan recommendation is to start with either a General Manager or a Technical Professional in the first year, performing portions of both duties as candidates become available.

It is recognized this position would be stretched thin, requiring the incumbent to perform a wide variety of duties. Additional administrative and water resource support would be provided by another "host" County Department. It is anticipated that additional consulting services for

technical studies and assistance would be needed, and those needs would be addressed by specific contracts funded and approved on a case-by-case basis. Not all the Agency's priority goals would be met. Additional Agency staff to support the General Manager would not be hired until future budget years.

We would have the new, stand-alone agency on board initially as the "face" of the organization, bringing leadership and expertise in water management, building trust with other water stakeholders in Mendocino County, representing County-wide water issues, and providing representation on existing water-related boards such as the Ukiah Valley GSP and the Inland Water and Power Agency.

Administrative Update	• In collaboration with the Executive Office and other departments and contractors, Facilities staff has submitted the final project applications for the \$5,404,000 in CDBG hazard mitigation grants allotted to Mendocino County last year. • The Space Utilization/Needs Assessment process with Nichols Melburg Rossetto Architects is continuing, county departments have returned staffing and space needs questionnaires. The architect is compiling this data and gathering facility information in preparation for site analysis. The County's architect has visited most County owned facilities in the Ukiah area. Additional site visits are scheduled for the Willits and Coastal facilities the second week of June. • Per board direction, staff is negotiating a performance-based Contract with Willdan to analyze county facilities for opportunities to enhance energy efficiency, power generation and electrification including vehicle charging and develop specific projects. Recommendations with specific project priorities and financing options will be presented for Board consideration and approval in the near future. • Facilities staff is developing a Memorandum of Understanding (MOU) with Anderson Valley Senior Center for continued use of the Boonville Veterans Hall. • Facilities staff participates in regular and ongoing interdepartmental meetings with Information Services, the Sheriff's Office and Social Services to ensure that the County has a coordinated effort to maintain and improve systems and facilities required for critical county operations.
Facility Maintenance and Operations	• Facilities has interviewed 10 applicants for two Grounds Maintenance Technicians and has extended conditional job offers to two candidates. Additionally, Facilities retired one 15-year Grounds Maintenance Technician. • In order to assure adequate support to our Coastal facilities, Facilities released an RFP for remote custodial and landscape support. Due to retirement and attrition, Facilities currently has only 1.0 FTE allocated position to service facility maintenance and repair on the coast. Due to this resource deficiency, staff from Ukiah are traveling to the coast daily to support the mandated services on the coast. GSA has been working with Human Resources on the meet and confer aspects of this service provision and anticipates contract award to be short term in duration, while continuing to recruit for a permanent employee for custodial services. Additionally, GSA will be presenting cost estimates to add 1.0 FTE Grounds Maintenance Technician on the coast due to no FTE allocated to serve the Coast. • Staff coordinated and performed emergent repairs to the jail kitchen water supply line when a catastrophic leak was found by an employee. The repair established an upgraded design that removed the supply from under the building ensuring future similar issues can be avoided. Total cost approximately \$7,000. • Staff repaired long time damage to protective fencing at Indian Creek Park. This deficiency was noted during the most recent parks assessment. • Staff has secured a contractor and commenced fire mitigation and vegetation management at Low Gap Park in preparation for the upcoming fire season. Although there is no dedicated funding for the parks identified, Facilities has utilized a portion of the PG&E set aside for parks hazards to address this critical park need. • Staff has deployed the comprehensive mobile generator usage plan in preparation for the upcoming PSPS fire season. All Facilities maintained mobile generators are

	deployed in desired locations per the plan and are hooked into the applicable buildings electrical infrastructure. • Staff has finalized preparations for a week long window repair at the Sanhedrin repeater site radio building. • Staff has procured a full inventory of battery powered industrial landscaping equipment to replace the gas-powered equipment in order to reduce the County's usage of fossil fuels (carbon footprint) and perform safer landscape operations during the fire seasons. • Staff has commenced a comprehensive mapping project of all services of all County Facilities. • Staff has answered two after hours emergencies this month for a total of 4 ½ hours OT. • Building Maintenance work orders received – 2,312 Fiscal Year to date. • Building Maintenance work orders completed – 2,364 Fiscal Year to date. • Current open Building Maintenance work orders – 190.
Fleet Operations	• In April, the Board adopted and approved the Enterprise Fleet Management systems for development of lease replacement model for County vehicle fleet with focus on fleet electrification and standardization with social services acting as pilot group. • Installation of new vehicle lift is complete. This replacement will allow for a higher volume of vehicle maintenance and repair. • Garage staff is working with purchasing to procure an updated tire/wheel balancing unit that will allow for the garage to more precisely perform tire mounting and balancing. • Garage work orders – 930 Fiscal Year to date. • Garage work orders completed – 916 Fiscal Year to date.

It is in design with procurement and bidding to follow. • The county wide repeater site hardening projects at Sanel Mountain and Sanhedrin Big Signal Peak will focus on back-up power, site access, waterproofing, fire hardening and equipment cooling and will be proceeding upon approval of the CDBG hazard mitigation grant applications.
Jail Expansion Readiness Projects	• The design for the Parking Improvement Project along Low Gap Road between Probation and GSA is complete and will be out to bid in June 2022 for completion prior to start of the Jail Expansion Project. • The West Campus Fiber optic build-out to extend the 10 gig fiber to each of the jail facilities and the GSA building prior to beginning the Jail Expansion Project design is complete and will be out for bid in June of 2022.
Emergency Projects	• Emergency hazardous tree removal is near completion at Bower Park having removed 125 dead and dying trees identified in the current arborists report as potential hazards Risk will re-assess the park to allow for it to reopen.

	Emergency HVAC system replacement is being designed for the Fort Bragg Veterans Hall. GSA has been in discussions with the Executive Office Fiscal team on the approach to this project. If designed correctly, Facilities would procure a more energy efficient HVAC replacement; however, this project has not been funded to date. The supply chain issues nationwide have impacted all areas of capital projects and maintenance. It is anticipated that this project will take approximately six months to complete from the time of funding. Currently, the Veterans Hall has no heating system and are using portable heaters as necessary.
Other Projects of Note	- The Fort Bragg Justice Center HVAC system replacement project is in design and, pending funding approval, will be released for bid this summer. - The County received bids for the demolition of the fire damage modular at the Low Gap entry; the contract is routing and demolition should be completed by the end of June or early July. - Construction of the Veterans Services Building Accessibility Project complete. - Initial feasibility work is complete and design for construction of a facility for the pretrial release program for the Jail is in process. - Design for new cooling equipment for the Administration Center server room is complete with bidding planned for July of 2022. - The Board directed that the Executive Office seek outside financing for several projects, including the Jail Expansion, completion of Phase III of the Administration Center Roof, the Fort Bragg Justice Center HVAC, and other roof replacements. Facilities has been in design for several of the projects for some time.
Measure B Projects	The Psychiatric Health Facility at Whitmore Lane site is in design with the initial demolition project due to be out to bid in early 2023, with new construction bidding by the end of that year.
SB 844 Jail Expansion	The County's architect is finalizing bidding documents for the Building 3 Jail Expansion Project having received state Fire Marshall and Planning and Building Services plan review comments. The project team anticipates bidding in the winter of 2022-23 subject to approvals by state and local oversight agencies.

CENTRAL SERVICES DIVISION

Real Property	- GSA staff is finalizing a surplus and sale of a portion of Road E (CR 233). County Department of Transportation has already abandoned the right of way. Anticipate final surplus and sale documents to be presented to the Board in mid-2022. - Lease negotiations for a potential lease of space for the GEO Day Reporting Center and Social Services/Family Center (co location) have been put on hold as the building was lost in an arson fire in May. Staff are working with the Community Corrections Partnership (CCP) for direction to proceed going forward. - GSA staff were given direction on March 28, 2022 to proceed with a sales agreement of a portion of County property known as the Point Arena Veteran's Memorial Building (APN 027-061-04). Final sale documents were presented to the Board and approved on June 7, 2022.
Parks	- Phase II emergency hazardous removal of dead and dying trees at Bower Park is complete. Phase II included removal of additional identified hazardous trees, totaling 125 trees removed. GSA is working with Risk Management on a remediation plan. Reopening will be considered soon. - Staff repaired long time damage at Indian Creek Park. This deficiency was noted during the most recent parks needs assessment. <u>Other parks considerations:</u> - Vegetation Management and Fuel Mitigation Plan. This plan will be presented to the Board, along with the operational and administrative budget during an upcoming Board budget workshop. There are critical needs in the parks systems in order to address safety concern, including fuel and fire mitigation.

	- Staff met with Mendocino Fire Safe Council (MCFSC) representatives on June 3, 2022, to discuss potential fuel and fire mitigation solutions throughout the County and in the County's Parks system. The discussion included conversation regarding several grant applications and/or awards associated with the completion of California Environmental Quality Act (CEQA) associated with potential fuel reduction projects within multiple County owned Parks. GSA and Executive Office staff will be working to determine necessary Board approval of said applications and will be collaborating with MCFSC to develop a priority list of risks and needs throughout the Parks related to fuel and fire mitigation which will include community outreach and input. - Coordinating and considering outside development interests. - Concession agreements.
Purchasing	- Compliance with Senate Bill (SB) 1383 is constantly evolving, and new programs will be initiated to meet compliance goals such as breakroom composting and food waste reduction. Currently, we do not have an exact timeframe for these programs. GSA staff is continuously working with vendors to procure goods which meet the required post-consumer recycled minimum content or 30%. These goods include but are not limited to recyclable or compostable paper products as well as office supplies. GSA staff continues to experience the increase in costs for household goods due to rising inflation factors. We do not know the exact cost, but it is estimated to be a 10% to 20% increase. GSA staff will continue to look for ways to reduce costs while meeting the goals of SB 1383. - The Department of Transportation was issued a memo regarding a purchasing violation that exceeded Policy No. 1 – Section 3.1 Goods. Violation has been noted and documented and per policy being reported to the Chief Executive Officer in this report. Specifically, Policy No. 1 - Section 3.1 Goods, reads as follows: "County Code Sec. 2.32.060 "Purchasing Procedures" requires that in the event the Purchasing Agent or designee purchases any individual item (as distinct from the total contract) costing more than Ten Thousand Dollars (\$10,000) without securing competitive bids or quotations thereon, the Purchasing Agent or designee shall report such action to the Board of Supervisors through the Chief Executive Officer, with his/her reasons therefore; and provided, further, that if the Purchasing Agent or designee does call for competitive bids or quotations and accepts any bid or quotation other than the lowest upon any individual item costing more than Ten Thousand Dollars (\$10,000), the Purchasing Agent or designee shall likewise report such fact to the Board of Supervisors through the Chief Executive Officer." All purchases over \$10,000 require an Exception to Bid or must follow competitive bidding guidelines; the violation issued was for a purchase exceeding \$10,000. - As a reminder, the purchase order deadline for the 21/22 fiscal year is 5pm on <u>06/20/22.</u>

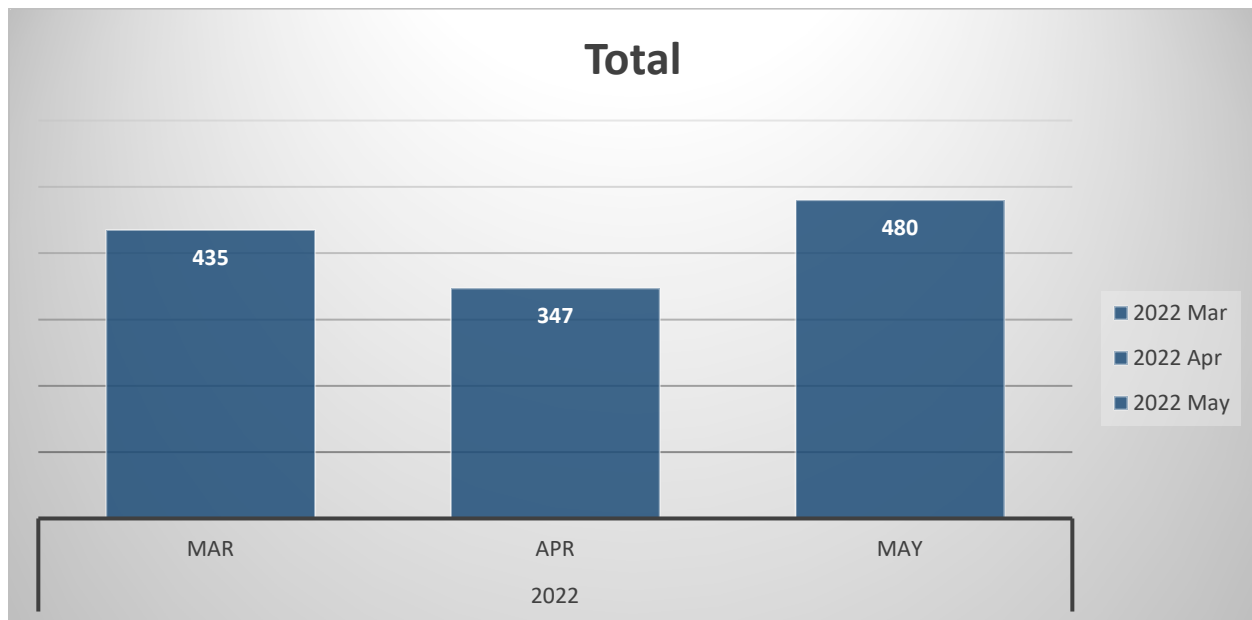

Public Safety Communications Update

Public Safety Communications Microwave Radio System MPLS Project Updates

All County Data services are fully operational on our new MPLS system. County IT staff has nearly completed the migration of the legacy audio circuits for the City, County, State and Federal allied Public Safety agencies that transport radio traffic over the County Microwave System.

Manufacturer training for County IT staff is being scheduled ASAP pending Vendor training staff availability.

Public Safety Communications South Coast Loop and Pt Arena Radar

The County South Coast Microwave Loop Project has been nearly completed, all equipment has been installed and commissioned. We are currently working with our vendor to finalize the last remaining tasks for full completion.

Public Safety Communications Simulcast Repeater Upgrade Project Update

The Simulcast Repeater Upgrade Project is currently proceeding on schedule. Currently the new County Fire Simulcast North and South Inland systems are fully operational on the new Simulcast repeaters with substantial positive feedback being received from several Fire Departments in the inland areas. Additional repeaters are being added to enhance radio coverage for North Inland Fire. Inland Sheriff and County Transportation Radio systems are being migrated to the new Simulcast repeaters. IT Division staff has completed all materials lists, documents and diagrams required for RFQ to purchase the materials required complete the Simulcast repeater project. RFQ have been issued to the appropriate vendor and contractors.

Geographic Information System (GIS) Update

The Information Technology GIS Staff, create and maintain the SDE Geo Database, a centralized source for the most up to date County GIS data for use with GIS stations in Departments throughout the County.

The Information Technology GIS Staff, create and maintain two GIS Portals, one on the County's Intranet for use by County Staff and one on the Internet for use by the Public. Due to internal changes from the software vendor, the inhouse GIS portal is experiencing an error message. A work around that alleviates this error is in place, however the long-term solution is to update the server and software that runs this older GIS Portal. GIS staff are working with Systems Administration staff to initiate a project to update both the inhouse and public GIS Portals.

Information Technology GIS Staff, create and maintain the GIS data layers in the Sheriff's dispatch system. GIS Staff complete monthly updates to Geo Database.

A set of maps were completed for LAFCO for the County Service Area 3 Benefits Zone study. This work was completed under our current service level agreement with LAFCO.

Information Technology GIS staff have been working with the City of Ukiah and their Engineering firm to resolve several issues concerning the City's latest rendition of the City boundary.

Development and Business Applications Update

Property Tax Software System (Aumentum)

Mendocino County's implementation of the Aumentum property tax system continues to make progress towards a functional system. However, we have faced challenges along the way. A ten-point list of items preventing a successful deployment has been identified and agreed upon by county stakeholders and Aumentum management. We have received status updates over the last few months on our number one item: conversion balancing. We expect significant progress,

if not completion, from Aumentum of balancing converted prior year tax bills against our legacy property tax system. Other items on our ten-point list continue to present challenges including corrections, supplementals, and notices. Despite these challenges, we anticipate closing the roll-on time this year due to the hard work and continued dedication of all those involved.

Enterprise ERP – Munis

The latest version of our Enterprise Resource Planning application, MUNIS 19.1, offers an exciting new way to maintain an up-to date application. Tyler Deploy is a big upgrade to the previous methods of installing bug fixes, security updates, and other binaries offered by Tyler Technologies. After a short exploration and testing phase of this new method of installing updates, the I.T. staff has managed to master Tyler Deploy. A simple monthly procedure will now ensure all necessary patches, fixes, and updates are available to county staff almost as soon as they are released.

Mendocino county continues to make strides toward releasing the new Employee Self Service application. This will allow employees to retrieve important information, such as W2 and paystubs. Additionally, this web-enabled extension to the MUNIS ERP will enable employees to self-maintain certain details of their employee records, such as emergency contacts and dependent information.

Cannabis Portal

1. The portal was re-opened for phase one and two permit applications for active participants of the original portal opening period.
2. Information Technology is in the process of preparing for renewals and phase three applications

Systems and Network Administration Update

The Systems Administration team has been providing ongoing updates and support for both Aumentum and Munis. The Network Administration team has been preparing for a switch upgrade at Public Health and working on setting up network services for the Sheriff's Office's Mobile Command Unit.

Office 365 Migration

The switch to Office 365 occurred May 6th. Novell Messenger was replaced by Microsoft Teams and Groupwise was replaced with Outlook. The Systems Administration team has been working diligently assisting users transition to the new systems. As we begin to wrap up the O365 project, we would like to thank everyone for their patience and support for this project.

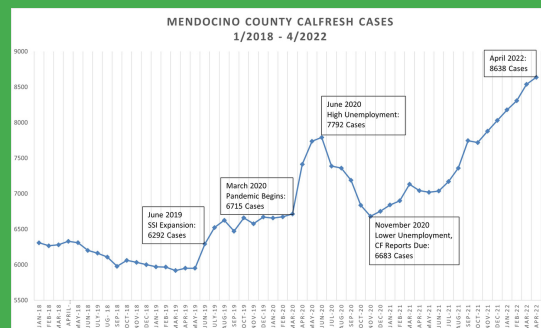

Medi-Cal Covid-19 Public Health Emergency Operational Unwinding Plan

The federal declaration of the COVID-19 Public Health Emergency (PHE) implemented over 100 programmatic flexibilities aimed at minimizing the strain to the Medi-Cal program and its beneficiaries, and California's health care providers. While many of these programmatic flexibilities will terminate, some will continue due to the positive impact they have left on the Medi-Cal program.

The PHE was set to expire on July 15, 2022, but the U.S. Department of Health and Human Services (HHS) has committed to providing at least a 60-day notice prior to the official end date, so it is anticipated to extend for at least one additional period.

Medi-Cal beneficiaries are encouraged to confirm the County has their current contact information on file, in case a redetermination is needed after the PHE is lifted. These redeterminations will be staggered over a 12-month period and will correspond to the current redetermination month for each case (although households have been exempt from providing redeterminations as part of the Families First Coronavirus Response Act). The intent of this process is to maximize continuity of coverage for Medi-Cal beneficiaries. Please contact Rachel Ebel-Elliott at (707) 463-7836 with any questions. 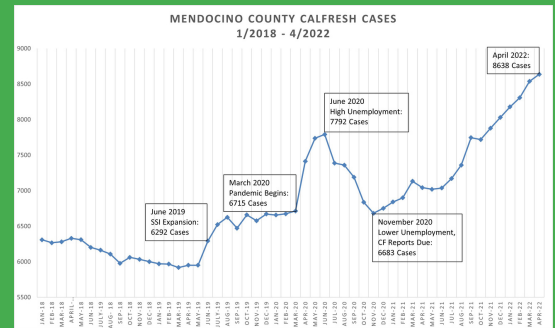

Medi-Cal Covid-19 Emergencia del Salud Publica Operación Desenrollo

La declaración federal de la Emergencia de Salud Pública (PHE) COVID-19 implementó más de 100 flexibilidades programáticas destinadas a minimizar la tensión para el programa Medi-Cal y sus beneficiarios, y los proveedores de atención médica de California. Muchas de estas flexibilidades programáticas terminarán, pero algunas continuarán debido al impacto positivo que han dejado en el programa Medi-Cal.

La PHE estaba programado para expirar el 15 de julio 2022, pero el Departamento de Salud y Servicios Humanos de los Estados Unidos (HHS) se ha comprometido a proporcionar al menos un aviso de 60 días antes de la fecha oficial de finalización, por lo que se anticipa extendido por al menos un período adicional.

Se alienta que los beneficiarios de Medi-Cal confirmen que el Condado tiene su información de contacto actual en el archivo, en caso de que se necesite una redeterminación después de que se levante el PHE. Estas redeterminaciones se escalonarán durante un período de 12 meses y corresponderán al mes de redeterminación actual para cada caso (aunque los hogares han estado exentos de proporcionar redeterminaciones como parte del acta Families First Coronavirus Response).
